Annual Fund FAQS

What does the Annual Fund Support?

Annual Fund giving supports financial aid for students in need, teacher professional development and learning via curriculum enhancement.

Why am I being asked to support the Annual Fund in addition to paying tuition?

Tuition alone does not cover the full expense for a student to attend Aspen Academy. As an independent school and 501(c)3 non-profit organization, Aspen Academy relies on the generosity of our community to improve and fund these critical areas that cannot be covered by tuition and fees.

Why not raise tuition?

Aspen Academy maintains the lowest tuition of the state's Association of Colorado Independent Schools. At our tuition levels, the school is able to make an Aspen Academy education more affordable to more families. Tuition and fees don't fully cover the costs of these areas so we, like every independent school, conduct an Annual Fund.

Many families appreciate the opportunity to claim a federal tax deduction and in some cases, a state tax credit. Gifts to the school are tax deductible, but tuition is not.

Who supports the Annual Fund?

We strive to receive 100% participation from current families, trustees, faculty, staff, administrators, grandparents and other friends.

How much should I give?

You are the only one who knows how much you are able to give, and we ask only that you give to the best of your ability. Gifts range from \$50-\$50,000. The median annual giving per student at an independent school in 2018-2019 was \$1, 644. We encourage each family to make the school a philanthropic priority especially while your children are in attendance.


Why is participation important?





Colorado Child Care Tax Information

Aspen Academy encourages donors to increase their gift and benefit from an up-to 50% Colorado Tax Credit. The Colorado Child Care Contribution Tax Credit was established to encourage greater private support of Colorado child care programs. Because select monetary contributions to Aspen Academy qualify for this tax credit, you may be able to decrease the aftertax cost of your gifts by more than 50%.


The effect of the credit is that up-to half of your donation to Aspen Academy is offset by a reduction of your Colorado income taxes. You will still be able to claim your full contribution as a charitable deduction on your Federal and State income tax returns if you itemize deductions. Examples of the total impact on your taxes are shown in the chart to the right. As always, you should consult with your tax advisor to determine how the credit will affect you personally.
