By initialing the commitment level and signing the registration form, you are agreeing to the terms of this business contract.

**Full Year Commitment:** I am committing my child to a full year of private music lessons instruction. I understand that the charge for a year will be (please initial your choice):

- \_\_\_\_\_ \$1,310 for 32 half hour lessons (30 minutes)
- \_\_\_\_\_ \$1,920 for 32 three quarter hour lessons (45 minutes)
- \_\_\_\_\_ \$2,535 for 32 one hour lessons (60 minutes)

**I understand this fee will be billed by Student Accounts and paid on the same schedule as my tuition plan (yearly, quarterly, and monthly).**

Because our teachers are active professionals in the music community, they have a limited number of openings in their schedules. The School of Music, Private Lessons Program cannot guarantee that all students who register will be able to participate in the lessons program. Students are accepted on a first come/first served basis with previous students and their families getting the option of pre- registration. Every measure will be taken to place each student. If lessons cannot be arranged by September 2, 2019, all monies will be refunded.

\*\*\*\*\*

Students are allowed to make up **two lessons** within the GACS school calendar for excused lessons only. An excused absence is one in which the School of Music Office or private lessons teacher receives 24 hours prior notice. Only lessons missed due to school closing or teacher absence will be re-scheduled.

In the event that a student/parent wishes to terminate instruction, a 30-day written notice to the School of Music Office is required. Lessons taken and lessons scheduled in the 30-day period are charged to the student. We encourage the students to complete the lessons in the 30-day period, but it is their choice. If withdrawing before a contract is complete, the amount refunded will be at a rate of \$35 for each lesson remaining in the contract period after the 30-day notice date.
