WASFA (Washington Application for State Financial Aid)

State Financial Aid for Undocumented Individuals and Select Non-Citizens

Washington State offers financial aid programs to students who aren't eligible for federal financial aid because of immigration status. These students still need to meet other program requirements.

DACA Update

On September 5, 2017, the federal government rescinded [Deferred Action for Childhood Arrivals \(DACA\)](#).

But in Washington State, undocumented students may still qualify for in-state tuition and for some state financial aid programs. Undocumented students need to meet one of the following standards:

The Washington Application for State Financial Aid or WASFA is a free application for state financial aid for students who are not eligible for federal aid because of immigration status, including undocumented students. After you complete the WASFA, the college(s) you choose will use your information to determine your state financial aid eligibility. State financial aid could include State Need Grant, the College Bound Scholarship, or State Work Study.



The parent email address **cannot** be the same email address the student used to create the account, and the parent **must** use this email address to create their parent account to be able to sign and submit the student's application.

- Revise y compare– quien le otorga la mejor oferta?
- Considere apelar la oferta si tiene circunstancias especiales.
- Acepte formalmente las ofertas de la universidad a la que decide ir.

4. No se olvide de renovar su solicitud cada año.
