



Joliet Central Incoming Freshman Registration Days January 25 and February 8, 2020

- The student and birth parent or legal guardian must attend together. Forms cannot be signed by any other person.
- Enter through doors on Eastern Avenue marked "H".
- Try to attend at your scheduled date and time. There is **NO** advantage in arriving early to choose classes. Scheduling is done randomly by the computer during the summer.

Note: Doors will close promptly at Noon on January 25, and 2:00 p.m. on February 8.

What will happen at Registration?

- Students and parents/guardians will meet with a counselor to choose elective courses.
- Each student will have an ID picture taken.
- Demographic and birth certificate information will be checked.

You must bring the following with you:

- **3 current proofs of address.** (see back of page for acceptable proofs of residency)
- **Parent/legal guardian photo ID.**
- **Student's Birth Certificate.** (student will not be fully registered until this is received)
 - If you are not the birth parent, please provide legal guardianship documentation.

Note: registration will not be complete until we receive all documents

Registration forms will be available at the event however you may choose to complete the forms before you arrive. Complete them and bring them with you.

Residency Proofs

Any three (3) of the following examples may be used to prove residency. Examples must be current (within the last month unless otherwise noted) and must show a billing and service address in JTHS District #204. Bill/payment stubs, “deposit required” letters, or any bill indicating a service may be or is interrupted or disconnected due to an unpaid balance are NOT acceptable proofs of residency.

IF YOU ARE A PROPERTY OWNER:

Acceptable proofs include:

- Electric Bill
- Gas Bill
- Water Bill
- Phone Bill
- Cable TV Bill
- Internet Bill
- Real Estate Tax Bill (last issued)
- Bank Statement

IF YOU ARE A RENTER:

Acceptable proofs include:

- Valid Lease (signed w/landlord contact number)
- Valid Renter’s Insurance Policy
- Electric Bill
- Gas Bill
- Water Bill
- Phone Bill
- Cable TV Bill
- Bank Statement

Note: If you do not own or rent the home in which you reside, you will need to complete an Affidavit of Residency and provide all required documents. Affidavits are available at registration and in the Principal’s Office at Joliet Central High.

Freshman Medical Needs

The state of Illinois requires every incoming Freshman to have a new physical AND a dental exam.

You will be receiving a Health Examination form and a Dental form at registration which you need to have completed by a doctor or nurse. Completed forms should be turned into the Principal’s Office by July 23, 2020.

Students will NOT receive their final schedule in August, and may not start school on time, unless we have an approved health form on file. We encourage you to make appointments with your doctor(s) as soon as possible to avoid the rush on physicians during the last days before school.

If you do not have a record of your child’s immunizations, please contact their junior high immediately to obtain a copy.
