These advisors spend countless hours helping the students prepare, and it enables the students to think deeply and creatively.

The JMI Math Club was founded eight years ago by Dr. Sinha, with nearly fifty students participating. The Math Club has grown to 150 students, who come to JMI every Monday night to work on difficult math problems. There are many parent volunteers who work with the students in small groups. Mr. Maeroff stated that Six years ago, Aimee Szilagyi, Veena Iyer, and he ran for seats on the Edison Board of Education as reformers, vowing to bring honesty and competence to a body that just a few months earlier had sent the superintendent home and had appointed an acting superintendent in her place. Ultimately, this action would cost the taxpayers a half-million dollars.

He said that eventually, like-minded people joined us on the board, individuals who sought to serve for the right reasons. Comprising such members, the board of education has been able to bring vast improvements to the education of the township's children, while pursuing a goal of fiscal sustainability.

Mr. Maeroff informed the public that he has been proud to have served on such a board. Now, as he is leaving, having chosen to conclude his tenure this month after six years, the last four as president. He decided last month not to file a nominating petition to run for reelection and knows that he leaves the board in good hands. Seated around him, Mr. Maeroff reflected, are dedicated and talented individuals who have made substantial contributions to the families of Edison.

The most important responsibility of any board anywhere is the selection of a superintendent. We have been indeed fortunate in that regard.

First, the Board chose Ron Bolandi, a retired veteran, to fill the role of interim superintendent while the district regained its bearings during a very difficult period after our budget was reduced by millions of dollars and much was in disarray. Mr. Bolandi was a settling force, who did the job well.

After seven months, a new full-time superintendent assumed the reins. That was Dr. Richard J. O'Malley, who now has completed, with distinction, more than three years in that role.

The fit between Dr. O'Malley and the board has been like a hand in the right-size glove and the ensuing collaboration has taken our school system to new heights. The board has backed Dr. O'Malley each step of the way as he has, to name just a few measures—

- o Upgraded instructional technology
- o Improved school security
- o Implemented a new reading program
- o Revised the secondary science program
- Created a science and technology academy
- o Filled key positions in the central administration and a the building principal level

Mr. Maeroff stated that he, in particular, because of his special interest in certain areas, has been delighted to see what the district has done in regard to—

- o A revamped gifted and talented program in the elementary schools
- o Adoption of Singapore Math in the elementary schools
- o Implementation of the AVID program in three secondary schools
- O Support of the district's instrumental and vocal music programs, which are undoubtedly among the finest in the state
- o And the attainment of greater diversity in board membership, making the board more closely resemble the composition of our enrollment

Mr. Maeroff said that he is proud, too, that the board and the Edison Township Education Association, our major and most important bargaining union, have achieved a level of good relations and mutual respect.

When Ms. Szilagyi, Mrs. Iyer and he first ran for the board in 2008, they said that it was essential that this school district hire personnel based on **what** they know, not **whom** they know. Thus, they have made great strides in combatting patronage and cronyism. Students deserve the best qualified personnel and taxpayers deserve to have their money spent on people who are in their jobs for the right reasons.

In advancing this goal, in six years on the board he has never put forth a resume to get anyone hired and has encouraged his board colleagues to act similarly.

This board and this superintendent have been about accountability. We have striven to put the district on a professional footing. Right now, under state mandate, the board and the superintendent are embarking on a new era of evaluation of both teachers and administrators. The plan is not perfect and some parts of it are rushed. Mr. Maeroff stated that he hopes, that in the long run, it will be an important tool for ensuring that all students get the most out of their education.

And so as he prepare to leave the board and his colleagues, with whom he has so much appreciated serving, he reminds everyone of four great challenges facing the board, the superintendent, and the school system.

*The first one came upon us suddenly and shockingly as result of the recent conflagration that consumed James Monroe Elementary School. The early response has been magnificent, reassembling the students and the staff while missing hardly a beat thanks to the leadership of the superintendent and the responsiveness of staff at all levels. In the long range, though, this district must construct a new building and have it ready in no more than two years.

*Second—and somewhat related to the facilities challenge that James Monroe poses—is the overcrowding that has gotten only worse during these last six years. We have added science wings at our two high schools, but little else by way of new construction. The last school built in Edison opened in 1972. A study the district commissioned showed last year that we are in desperate need of additional school buildings. Almost all of our schools were built to accommodate hundreds of fewer students than now attend them.

*Third, the district is understaffed in terms of administrators. Some observers criticize the notion of adding administrators, but they are ill informed. Edison is near the bottom in the state in the number of administrators we have per pupil. The problem is particularly acute in terms of the state's new evaluation mandates. In some cases, the number of observations per teacher will increase three-fold. Who will handle these evaluations? We have monster elementary schools, some of which are approaching enrollments of 1,000. And we have no assistant principals in the elementary schools. This situation has to change if we want to continue to pursue excellence and to respond properly to new demands for increased teacher evaluation.

*Fourth is the disparity in achievement between schools in the North and in the South. This board and this administration have done more to try to heal this schism than perhaps any prior board and administration. We now undoubtedly spend more per pupil on schools in the South than in the North. We use federal Title I funds to great advantage in this effort. We have added literacy and math interventionists. We have introduced Saturday programs for students and ESL classes for their parents. Some principals and teachers have attempted to change the culture in those buildings to emphasize the .primacy of academic achievements. These efforts must continue. Edison is one school district, not two.

In the end, what the board does by way of maintaining and pursuing educational excellence redounds to the benefit of everyone in this town. The public schools are the greatest attraction that Edison has. They are magnets that draw and hold families. Let the quality of education slip in any way whatsoever and the value of every home in Edison will decline, whether or not the owners use the public schools.

In closing, Mr. Maeroff thanked the citizens of Edison for giving him the privilege of serving two terms on the school board and thanked his colleagues on the board for their support and their hard work.

XV. COMMITTEE REPORTS

1. Finance & Facilities Committee

Dr. Heelan reported that the Finance and Facilities Committee met at 10:00 A.M. on March 13, 2014 at the Education Center.

In attendance were: Dr. Richard O'Malley, Mrs. Veena Iyer, Mrs. Deborah Anes, Dr. Frank Heelan, Mr. Daniel Michaud, Mr. Kenneth Stromsland and Architect, Thomas Rienzi

Discussion:

- Mr. Rienzi reviewed the heating problem in the new Edison High School Science Wing and informed the Committee that the manufacturer of the heating/air conditioner unit was currently diagnosing and repairing it. Mr. Rienzi expects the issue to be resolved within the week.
- Specifications for roofing bids are now being prepared for Herbert Hoover Middle School, John Adams Middle School and John Marshall Elementary School. The bids will be opened on April 16th and awarded at the board meeting on April 28th.
- An updated copy of the proposed 2014-2015 Budget was distributed with the State Aid figures. State Aid revenue increased by \$284,540: \$142,270 for PARCC and \$142,270 for Per Pupil Growth Aid. With a 2% tax levy increase the total estimated tax impact for 2014 will be \$52; fortunately, the tax ratables increased by \$30 million that will restrain the tax impact.
- Two transportation vehicles (24-30 Passengers) that have more than 250,000 miles need to be replaced. Buses with electronic doors and built-in car seats cost in the range of \$55,000-\$60,000 each.
- Mr. Stromsland reviewed the summer project plans for Chartwells Kitchen/Serving expansion and renovaitons in Benjamin Franklin, Menlo Park, Lincoln, Lindeneau, Washington and Woodbrook Elementary Schools and James Madison Primary School. In Thomas Jefferson Middle School, the current outdoor walk-in refrigerator will be eliminated and a new combination freezer/refrigerator, having indoor access, will be installed. With John P. Stevens High School serving as the District hub for food distribution, discussion ensued on possibly setting up in the future a second hub for the south end.
- The Finance & Facilities Committee will convene on Thursday, April 10, 2014 at 9:30 AM in the Education Center.
