Township Liaison Committee

The Township Liaison Committee met on August 10, 2017 in the Edison Council Chambers, 100 Municipal Boulevard, Edison, NJ.

In Attendance: Edison Board of Education Board Members: Shivi Prasad-Madhukar, Dr. Frank Heelan, Beth Moroney, Ralph Errico and Edison Council Member, Robert Diehl

Discussion:

- 1. Need for a new school because of severe overcrowding: The Committee discussed the urgency of finding open land in Edison that can be used for building a new school. Mr. Diehl spoke about several options, including razing Stelton Community Center, although there might not be enough land there. He mentioned some available land around Talmadge Road; but that would also not suffice for a high school and would most likely be good for an elementary school, because there is not enough space for an althetic field. Raritan Center and land around Middlesex County College were mentioned as other regions that must be explored. The Committee discussed hurdles in finding viable land in Edison because of several restrictions, such as land deemed for recreation and Open Space, etc.
- 2. Other items of discussion included a survey being conducted to study the viability of land between John Adams Middle School and John P. Stevens High School for building a new high school.
- 3. The Committee discussed the Woodbridge pilot program that allowed a construction of a new school without increasing taxes and how this could be achieved in Edison.
- 4. Traffic around school arrival and dismissal times was another topic of discussion. The Committee discussed ways to coordinate efforts to improve safety.
- 5. The Council representative spoke about an environmental sustenance group called SENSE that wants to make a presentation to the Board of Education.
