- *Family Support Center of New Jersey: Operates a statewide toll free number 1-800-372-6510 for family members, professionals and other interested individuals to call for access to a broad array of support services geared to families caring for a child with a disability, medical condition, special needs, etc.
- *Special Child Health Services Middlesex County Case Management Unit: This program provides
 Comprehensive Case Management for special needs children from birth to the 22nd birthday who may have a
 disease, disorder or condition that may interfere with normal growth and / or development. The program offers
 resources and referrals to community, state and federal programs. Upon referral, the child is assigned to a Case
 Manager who completes an assessment and explores ways to meet the child's needs. The Case Manager also
 develops a comprehensive plan of care for the child which includes medical, dental, developmental, educational and
 social, emotional and economic areas. Call (732) 745-3100 for information.
- **Special Note: Assistance or services may not be found to be needed right away. Sometimes issues arise in children after the fact, weeks or months after. Parents may also contact their private insurance or Medicaid HMO, speak with a Care Manager and ask for services when school is out if they are found to be needed.
