The legal voters of the Barre Unified Union School District who are residents of the City of Barre and the Town of Barre, are hereby notified and warned to meet at their respective polling places: Barre City residents meet at the Barre City Municipal Auditorium and Barre Town residents meet at the Barre Town Middle and Elementary School gymnasium; on Tuesday, March 3, 2020 between the hours of seven (7:00) o'clock in the forenoon (a.m.) at which time the polls will open and seven (7:00) o'clock in the afternoon (p.m.) at which time the polls will close; to vote by Australian ballot upon the following Articles of business:

ARTICLE I

To elect three members to the Barre Unified Union School District Board for the ensuing term commencing March 4, 2020 as follows: ~One Barre Town Director for a term of three (3) years.

~Two Barre City District Directors for a term of three (3) years.

ARTICLE II

Shall the voters of the Barre Unified Union School District approve the school board to expend \$48,479,968, which is the amount the school board has determined to be necessary for the ensuing fiscal year? It is estimated that this proposed budget, if approved, will result in education spending of \$15,078 per equalized pupil. This projected spending per equalized pupil is 11% higher than spending for the current year.

ARTICLE III

Shall the voters of the school district approve the school board to expend \$3,130,436, which is the amount the school board has determined necessary for the support of the Central Vermont Career Center for the ensuing fiscal year?

ARTICLE IV

Shall bonds or notes of the Barre Unified Union School District in an amount not to exceed Two Million Dollars (\$2,000,000), subject to reduction from available state and federal grants-in-aid and other financial assistance, be issued for the purpose of acquiring real estate located at 91 Allen Street in the City of Barre, and rehabilitating the same for use by the Spaulding Educational Alternatives program, the estimated cost thereof being Two Million Dollars (\$2,000,000)?

RESOLUTION CERTIFICATE

I do certify that I am the duly elected and qualified Clerk of the Barre Unified Union School District (the "District"), a municipal corporation located in the County of Washington, State of Vermont; that I have custody of the books, records and seal of the District; and that the following is a true and exact copy of a resolution unanimously adopted at a regular meeting of the Board of School Directors of the District, duly called, noticed and held on January 9, 2020 at which a quorum of members was present and voting; and that the same remains in full force and effect, and has not been amended, rescinded, abridged, modified or contested in any way;

"WHEREAS, the District owns, maintains and operates a system of public education; and

"WHEREAS, the public interest and necessity demand, and it has been so found and determined by the Board of School Directors, that certain improvements be made, namely, the acquisition of improved real estate consisting of a barn and 8.7 acres of land located at 91 Allen Street in the City of Barre, and the renovation of the same for use by the Spaulding Educational Alternatives Program, at an aggregate estimated cost of Two Million Dollars (\$2,000,000); and

"WHEREAS, it was found and determined that the cost of making such improvements, after the application of available state and federal grants-in-aid and other financing sources, would be too great to be paid out of the ordinary annual income and revenue of the District; and

"WHEREAS, the economic feasibility and benefit of making such improvements have been established to the satisfaction of the Board of School Directors; and

"WHEREAS, all necessary state and federal licenses, approvals and permits have been secured with respect to the subject improvements, and the financing thereof, or are reasonably anticipated to be secured in due course; and

"WHEREAS, the following proposal for the incurring of debt in an amount not to exceed Two Million Dollars (\$2,000,000), for the purpose of making and financing such improvements, shall be submitted to the legal voters of the District at the annual meeting thereof on Tuesday, March 3, 2020:

Article IV: Shall bonds or notes of the Barre Unified Union School District in an amount not to exceed Two Million Dollars (\$2,000,000), subject to reduction from available state and federal grants-in-aid and other financial assistance, be issued for the purpose of acquiring real estate located at 91 Allen Street in the City of Barre, and rehabilitating the same for use by the Spaulding Educational Alternatives program, the estimated cost thereof being Two Million Dollars (\$2,000,000)?

"BE IT FURTHER RESOLVED, that all acts, matters and things relating to the proposition of financing such improvements, as well as the maintenance and operation of such improvements within the corporate limits of the District, be in accordance with the provisions of Chapter 9 and 11 of Title 16, and Chapter 53 of Title 24, Vermont Statutes Annotated, as now enacted and as may be amended; and

"BE IT FURTHER RESOLVED, that the attached Warning be adopted for use in connection with consideration of the above-stated proposition.

January 9, 2020 DRAFT PROCEDURE Response to Community Correspondence

The Board values input and correspondence from community members on matters related to the governance of the school district and wants the community to know that their input is heard. When the board receives correspondence though email or other online means, a response will be sent acknowledging the correspondence using the following protocol:

- Who will respond:
 - If the correspondence falls under the purview of a particular committee of the board (i.e.; Finance, Facilities, Curriculum, Communication, Policy, Negotiations, etc.) then the chair of that committee will send a response acknowledging the correspondence.
 - If the correspondence falls under the purview of more than one committee, then the chairs of the committees will coordinate on a response.
 - If the correspondence is not specific to any particular committee, or if s/he feels compelled, the board chair will respond and/or coordinate with the committee chair(s).
- All attempts will be made to respond reasonably promptly
- All board members will be included on the response: (1) so that all board members are aware of the input and response; and (2) because the respondent is speaking on behalf of the board.
- Any administrator included on the correspondence will be included on the response.
- To avoid any conflict with open meeting laws, the response will not go into any level of detail about board business and will include a statement such as:
 - "In order to avoid any conflict with Vermont open meeting laws, we cannot go into details about board business here, but we do want you to know that we acknowledge and value your input."
