INTRODUCTION: Pursuant to California Public Contract Code (PCC) §22000 et seq., Lodi Unified School District (“District”) hereby seeks lump sum bids in response to this Informal Invitation for Bid No. 2020PW01 for its Maintenance & Operations Laydown Yard (Project) 66,000 square feet gravel yard, remove and replace stock pile of existing soil directly West of area of work, recompact all areas to receive fill to a depth of 18”, grade entire area to drain at 1% slope from South to North, compact all areas to 12” of 90% compaction and finish grade, import, place and compact 6” of Class 2 aggregate base rock, finish grade and compact aggregate base rock to 95% compaction, finish grade entire aggregate base rock area, aggregate base rock to drain at 1% slope from South to North.

REQUIRED CONTRACTORS LICENSES: Each Bidder shall be a licensed contractor pursuant to the California Business and Professions Code §7028.15 and California Public Contract Code §3300, and shall be licensed in the following classification as required by the scope of work: A or B license
Any Bidder not meeting the license requirement(s) following the bid opening will be rejected as non-responsive.

BONDS REQUIREMENT: Payment and Performance Bonds equal to one hundred percent (100%) of Bid.

PREVAILING WAGES: The project is a public works project subject to California Labor Code §1770 et seq., The Director of Industrial Relations has determined the general prevailing rate of per diem wages and the general prevailing rate for holiday and overtime work in the locality in which the work is to be performed, for each craft, classification or type of worker needed to execute this contract. Per Diem wages shall be deemed to include employer payments for health and welfare, pension, vacation, apprenticeship or other training programs, and similar purposes. Copies of the rates are on file at the District's principal office. The rate of prevailing wage for any craft, classification or type of workmanship to be employed on this Project is the rate established by the applicable collective bargaining agreement which rate so provided is hereby adopted by reference and shall be effective for the life of this Agreement or until the Director of the Department of Industrial Relations determines that another rate be adopted. It shall be mandatory upon the selected contractor and on any subcontractor to pay not less than the said specified rates to all workers employed in the execution of this contract. Contractor shall post on site all required job site notices as prescribed by law or regulation.
