Tuition Assistance

Tuition assistance is available for students in grades K – 12. Families interested in tuition assistance should complete the:

- **School and Student Service for Financial Aid (SSS) Application Form** (sss.nais.org). Our school code is #1165. Awards are granted based on availability of funds. Tuition assistance is awarded annually to **students in grades K – 12**. Tuition assistance is not available to Form I-20 students. Applying for admission to The Bear Creek School and applying for tuition assistance are two separate processes. - **Sibling Subsidy Request Form**. This form needs to be sent to the Business Operations Manager (Main building at Redmond Campus) by **February 3, 2020**. The Sibling Subsidy provides a 2.5% discount for **families with multiple children in grades K – 12**.

Tuition and Fee Payment Options

Tuition, Facility Fee, Division Fee, and Senior Fee may be paid in two ways:

- **Payment in Full:** All domestic students receive a **2.0% tuition discount** if tuition is paid in full before **May 5, 2020**.
- **Ten Equal Monthly Payments:** The Bear Creek School uses a tuition remittance program called FACTS for the ten-month tuition and/or facility fee payment option. **Payment is due on fifth (5th) of each month** (May 2020 – February 2021). The annual fee for FACTS is \$45.00.

Tuition Insurance

- **Tuition Insurance is recommended** and is available through a number of insurance companies, including but not limited to A.W.G. Dewar Inc. Tuition Refund Plan. The A.W.G. Dewar Inc. plan provides an opportunity to insure tuition in the event of withdrawal under certain circumstances. Be sure to read the policy carefully to make sure you understand the terms, conditions, and dates of coverage. For more information, please see www.tuitionrefundplan.com.
- The Bear Creek School has negotiated a **premium of 1.9%** of the annual tuition (less tuition assistance, scholarships and discounts) with A.W.G. Dewar Inc.'s Tuition Refund Plan. If you choose to participate in the A.W.G. Dewar Inc. plan and indicate this choice on your child's Enrollment Contract, your tuition insurance payment(s) will be included with your choice of payment schedule.

Fees

Enrollment Fee	\$300.00 per domestic student (preschool – grade 12). This fee is due each year to reserve a space upon enrollment. This fee is Non-refundable.
Facility Fee	\$2,000.00 per family: This is an annual fee for K – 12 students which funds the annual cost of facility maintenance and improvements. It is due with monthly tuition payments or in full by May 5, 2020.
Division Fee	Grade K – 6: \$100.00 per student. Includes PTF dues and field trips. Grade 7 – 8: \$300.00 per student. Includes PTF dues, ASB dues and book rental fees. Grade 9 – 12: \$500.00 per student. Includes PTF dues, ASB dues, book rental fees, and student issued Microsoft Surface.
Senior Fee	\$325.00 per senior (grade 12 only): This fee covers Senior Blast Trip, cap and gown rental, and Commencement video.

Additional fees may include: AP exams, yearbook, competitions, learning aids, athletics participation, etc. These fees are subject to change and are due from time to time, throughout the year.

Form I-20 Students

All other student fees apply.

Please note that complete payment of tuition, fees (including supplemental fees), and insurance premium must be paid in full upon initial or subsequent year enrollment of Form I-20 students (no monthly payments). If a Form I-20 is needed immediately, we must receive full payment by money order or wire before issuing this document. No tuition discounts apply for Form I-20 students.

Form I-20 Student Enrollment Fee	\$500.00 (Non-refundable) per Form I-20 student. This fee is due each year to reserve a place upon enrollment.
Form I-20 Student Services Fee	\$2,000.00 (Non-refundable) per Form I-20 student is due in full upon initial enrollment or subsequent year enrollment.
Form I-20 Student Supplemental Fee Deposit	\$1,000.00 (\$1,500.00 for seniors): Various supplemental fees are incurred by Form I-20 students throughout the course of the academic year. The Bear Creek School will charge the Form I-20 student account as supplemental fees are incurred and will provide an itemized statement upon request. Unused balances will be applied to the next academic year or refunded if the student does not return. In the event fees are greater than the deposit, the family will be invoiced.
Mandatory Accident and Health Insurance Premium	\$1,500.00 for eleven (11) months: August 1, 2020 – June 30, 2021.
