To buy tickets, you need all of the following:

1 signed permission slip/emergency card

1 school picture ID

(If bringing an off campus guest- guest must have an approved guest pass through the Activities Office)

If you purchased your ticket as part of a Registration Package, you must drop off your completed permission slip/emergency card to the Student Store or Accounting by Thursday, February 20th. If you are unable to attend Winter Ball, you may request a refund of your ticket price no later than February 17th.

Off Campus Guests:

If your guest is not from QHHS, you need to complete a guest pass request, contract, and emergency card. Your guest must be approved before you buy your ticket. The deadline for guest pass requests/approvals is Wednesday, February 19th, 2020. Guests cannot be older than 20 years old. ***After completing a guest pass, it must be brought to the Activities Office to be approved.*** You will not be able to purchase your ticket until your guest has been approved.

Tickets will be sold between January 21st and February 21st, 2020 or until tickets are sold out (Maximum 450).

Information

1. All rules and policies in the QHHS Online Student Planner are in effect.
2. Freak dancing, grinding, and similar sexually suggestive types of dancing are not appropriate for a school-sponsored function. Students who engage in this type of dancing will be removed from the dance.
3. The AVUHSD has a "ZERO TOLERANCE" policy. This means NO drugs, drug paraphernalia, alcohol, or tobacco.
4. To enter the premises, you and your guest (if applicable) must have a picture ID and your ticket receipt.
5. To purchase your tickets, you must have your picture ID (school ID), and the "Permission Slip/Emergency Card" signed by a parent or guardian. If you are purchasing tickets for an off campus guest, they must be on the approved guest list (application, permission slip, emergency card available in Activities Office).
6. We are not providing security in the parking lot while we are at the dance. We will do our best to watch your cars. However, we ARE NOT responsible for their safety. High profile cars are always a target. Use good judgment.
7. Parents or the person on the emergency card will be called to transport students home if violations of school policy/ED code occur. As a result, seniors may not walk at graduation.
8. You MAY NOT sell or give your ticket to another student.
9. All guests attending Winter Ball are the responsibility of the QHHS students with whom they are attending the event.
10. You may buy your tickets beginning January 16th in the Student Store and Accounting. No refunds. No exceptions.
11. Please be prepared to be searched at the door. You may not be able to enter the premises.

12. **DRESS CODE:**

Attire is semi-formal. Only modest and age appropriate clothing may be worn.

Male dress:

No sagging pants, canes or chains, bandanas, head rags, or baseball caps allowed.

Female Dress

- No sheer/see-through material between mid-thigh and bust area. No exposed undergarments.
- No overly revealing body parts. (No bare midriff, no bare lower back, no key hole cut-outs, no plunging bust line, slits must be at the mid thigh or lower, dress/skirt length cannot be shorter than mid thigh.)

Inappropriate dress will result in a student or guest not being allowed entry to dance.
