Treasurer's Report:

Report was passed out.

New Business:

1. Minutes for December 2019: Motion to approve by Ms. Gomez, Ms. Bell seconded.
2. Recap of Holiday Event:
 - a. Results of Raffle Winnings shared. 4th grade's Lotty wreath earned the most, with 2nd graders S'mores fire pit coming in second. PTO earned \$159.17 from Holiday Shop. Rec'd feedback from families that we should offer that more than 1 night only. Shared concern with families that it takes volunteers in order for that to happen.
 - b. Plaster Cottage, Dew Berry Art, & Mr. Softee all asked to think about them again for next year's Holiday Event.
 - c. Thanked teachers for giving time in helping make the event a success. Teachers rec'd feedback from families - they enjoyed themselves and were happy the crafts were free.
3. Movie Night:
 - a. PTO has hired Premiere Outdoor Movies or Orlando (located in Oakland) for the event. They provide all the equipment needed - PTO only needs to provide the movie. Total cost of rental is \$384.86. Movie will start at 6:30 to allow families who pick up at MOST around 6pm to join in the fun. Opening the gates at 6pm so families can eat and select seating.
 - b. Movie: Voted and approved to show "Abominable Snowman" - rated PG, 1 hr and 37 minutes long. Netflix has this movie available for rental - Ms. Stansell will provide it for us. Back up movie is Toy Story 4, which Renee' Cole owns. Motion to approve movie by Ms. Gomez, Ms. Guy seconded.
 - c. Concessions: Voted and approved for Mr. Softee and Taco Truck to be present at event. PTO will request both vendors to give back 10% in sales. Additional concessions provided by PTO will be: Popcorn \$.50, Goldfish packets \$.25, and drinks \$1. Motion to approve Mr. Softee by Ms. Guy, Ms. Mickens seconded. Motion to approve Taco Truck

Ms. Gomez, Gricelda Monero seconded. Information sent to Ms. Mayhugh for her approval. (Taco Truck family has two children who attend Mascotte Charter, that is how PTO find them).

- d. Discussion of what needs to be included on the flyer. Needs to be in both English and Spanish. Reach out to Ms. Lopez on the number of flyers needed in Spanish. Flyers need to include: families that bring chairs to sit in to be courteous and sit in the back of the crowd. Try to put 4 flyers on one sheet of paper to help with printing.
 - e. Ms. Johnson shared her concern to have more security than just Mr. Stansell. PTO is offering the incentive to teachers for this event, which will provide more eyes. Will also reach out to families who have Law Enforcement members to attend event for extra help too.
4. Presented the School Supply Fundraiser to teachers. Explained how the fund raiser works, passed around the sample box, and talked about the pricing. Teachers liked the idea of this fundraiser - teachers receive exactly what they need. Motion to approve moving forward with fundraiser by Ms. Gomez, Ms. Guy seconded. Information sent to Ms. Mayhugh for her approval.
5. Open Floor:
- a. Teachers suggested PTO should start sending out flyers home to families letting them know a PTO meeting is coming up. Ms. Guy will be sharing what Kinder sends out for PJ day as an example. Also pushing reminders on Class Dojo, which this needs to be approved by Ms. Mayhugh.
