BUDGET HEARING

A Budget Hearing was held to present the 2017-2018 budget approved at the May 9th Budget Committee Meeting. The Board received comments from OSEA Director of Fiscal Services, Brad Larsen.

The Board approved Resolution 16-17-16: Adopting the 2017-2018 Budget, Making Appropriations and Levying Ad Valorem Taxes.

Dr. Washburn presented Policy JFC: Student Behavior Standards and Expectations. The Board approved the revised policy as recommended for First Reading.

As part of our ongoing technology replacement program, the Board has authorized the \$64,000 purchase of MacBook Air computers for RHS teachers to positively impact high school student instruction.

The Board approved Resolution No. 16-17-17: Authorizing Budget Appropriation Transfers for budget year 2016-2017.

Roseburg High School Foundation Proposal:

RHS Booster Club members, former RHS Principal, Karen Goirgolzarri, and Brian Prawitz shared a proposal from the current booster club membership to begin transitioning to a 501(c)3 non-profit organization with a focus on meeting student needs including scholarships, classroom grant requests and capital projects, etc. The members intend that the proposed foundation should be structured for the benefit of students who attend Roseburg High School.
