Action Items: The Board approved the Consent Agenda that consisted of Minutes from January 10, 2018 and Surplus Items.

Dr. Washburn announced resignations including Debra Gaddis, Choir Teacher at Joseph Lane Middle School after 23 years in the District; and Turnaround Program Special Education Teacher Drew Bauguess, after seven years with the District.

A Memorandum of Understanding between the District and the Roseburg Education Association (REA) regarding "Fair Share" was tabled for further consideration at the February 14th Board Meeting when all Board members can hopefully

be able to attend.

The District will soon begin to solicit bids for turf replacement at RHS. In anticipation of that project, the Board has approved t h e recommendation to contract with FieldTurf USA through the InterMountain ESD purchasing cooperative for the RHS track resurfacing.

District Teaching and Learning Director, Robert Emerson, presented the annual Division 22 Standards Report to the Community as required by Oregon Administrative Rule (OAR) 581-022-2305.

Policy IGBI: English as a Second Language, with minor revisions, was Approved and Adopted at First Reading.

Policy IGBA: Students with Disabilities — Child Identification Procedures, was Approved for Second Reading and Adoption.

Chief Operations Officer, Cheryl Northam, shared a 2018-19 Budget Calendar for the Board's consideration. The Calendar was approved and Budget Committee members will be scheduled to meet on April 18th to begin reviewing the proposed 2018-2019 budget document.
