# **Action Items:**

The Board authorized legal counsel to negotiate a separation agreement with the Superintendent including payment of severance pursuant to his contract and a release of all claims.

The Board authorized moving the duties of the Superintendent as an Interim to the Director of Human Resources, Robert Freeman.

The Board then approved placing the Superintendent on administrative leave while legal counsel negotiates separation and terms.

The Board approved the Consent Agenda consisting of the Minutes

from July 11, 2018, a list of Surplus items and hiring recommendations for the 2018-2019 school year, including:

Board Chairman Garcia presented the proposed 2018-19 Board Committee roster. The roster with one modification was then approved.

The annual designation of supervisory and confidential employees was also approved by the Board.

A Memorandum of Understanding (MOU) between the District and Adapt to provide student mental health services beginning with the 2018-2019 school year was approved by the Board. Adapt CEO Dr. Brigham and Youth and Family Director, Bill Shobe, assured the Board that Adapt has identified working with schools in the deployment of mental health therapy to students as an immediate priority. Adapt has begun hiring therapists as part of their commitment to this collaborative partnership to provide necessary student mental health supports.
