Superintendent Lee Paterson wrapped up his final Board Meeting with a promised status report on a long list of goals he had set for himself this school year. Many had been updated earlier in the meeting, such as the Emergency Preparedness Plan created by a talented District taskforce; the RAVE Panic Button pilot project; a progress report on the Extra Curricular Salary Schedule, and the TAG Program targeted to begin this fall, also led by a highly skilled team selected by Director Robert Emerson. Chief Operations Officer, Cheryl Northam, is identifying a date for the Work Session in which the Board will hear details of the proposed Long Range Facilities Plan. And finally, we hope to be updated on both the Rose and RHS accreditation report in July.

The Board approved the Consent Agenda including May 22nd Minutes, Surplus Items and recommended hires for 2019-2020 as follows:

Annual Budget Hearing:

Chief Operations Officer, Cheryl Northam, presented the 2019-2020 Budget document for Board consideration. The public was provided the opportunity to give feedback. The Board approved a proposed increase in budget appropriations as requested.

Resolution 18-19-19: Adopting the 2019-20 Budget in the total sum of \$90,523,598 and Making Appropriations and Levying Ad Valorem Taxes was approved.

The "Healthy and Safe Schools" Plan for our District was approved as required.

The Service Provider Agreement between the District and Umpqua Community College to provide GED and Adult Basic Education services to students at the Wooley Center for the 2019-2020 school year was also approved by the Board.

Policy EFAL: Child Nutrition, was determined to be out of date and was approved for rescission.

The Board adopted middle school Social Studies instructional materials in the amount of \$88,380 from Discovery Education.

The Board received updates from high school administrators, Principal Jill Weber and Asst. Principal Adam Blue on the RAVE emergency mobile safety notification program that has been successfully piloted this year at Roseburg High School.

The Board had continued discussion regarding updating existing policy governing commercial advertising in district facilities. It was suggested that a committee discuss this at a deeper level.

Teaching and Learning Grant Manager, Dani Jardine, gave an exciting overview of staff activities over this school year in the Collaboration Grant world.

Human Resources Director, Robert Freeman, updated the Board on his work in analyzing the existing extra-curricular salary schedule. Additional committee work is necessary before any modifications are reviewed for Board approval.

PLC (Professional Learning Community) Discussion

Child Development Specialists, Laura Harvey and Kristin Miller, and Psychologist Kelly Kirk presented an update of their work this year in launching a new and effective system for identifying and serving our students in the upper 97th percentile.
