Superintendent Cordon thanked the Board for accepting the challenge of reviewing facility materials in preparation for an in-depth discussion at the next Board Meeting to move forward with long-range planning. Jared enjoyed working with Director Micki Hall at the recent OSBA Summer Conference. He acknowledged Director Rod Cotton's efforts in securing the \$2,643 McDonalds' donation in support of the District Pre-K program. The Board will talk about preparing for the Student Success Act as part of their Board Work Session this Friday.

Action Items:

The Board approved the Consent Agenda that consisted of Minutes from the July 10th Board Meeting; Gifts to the District; Surplus Items and the following hiring recommendations:

- Briana Dickson, a Kindergarten Teacher at Sunnyslope School;
- Adam Finlayson, Teaching & Learning Support Specialist at Sunnyslope School;

- Katherine Newman, a First Grade Teacher at Hucrest Elementary School; and
- Nathan Williams, Special Education DLC Teacher at Roseburg High School.

Also acknowledged were resignations as follows:

- Elaine Logan, Special Education Teacher at Fir Grove Elementary; and
- George Graham, Language Arts Teacher at Joseph Lane Middle School, who intends to retire at the end of the 2019-2020 school year after 32 years in the District.

The Board approved the proposed roster of Board Committees for the 2019-2020 school year.

Designations of Supervisory and Confidential Employees were approved for 2019-2020.

A purchase of 216 Chromebooks and console licenses to support digital curriculum in Science at both Fremont and Joseph Lane Middle Schools, and Health at Fremont Middle School, with a cost of \$45,144 (Chromebooks) and \$5,995 (carts) respectively from CTL Corporation, was approved by the Board.

Superintendent Cordon led a discussion regarding long-range planning and bond consideration pursuant to the recent Educational Facility Assessment and Long-Range Planning report provided by Cooperative Strategies. The Board and Cabinet explored various options to consider with respect to facility repairs, restoration and replacement along with their associated costs. Board members will evaluate the information and be prepared to have further discussion on August 28th as to the desired pathways to maintain our facilities in optimum condition while keeping in mind the future educational needs of the students we serve at Roseburg Public Schools.

Professional Learning Community (PLC): Rose Alternative School Accreditation:

Rose School Principal, Randal Olsen, shared the Exit Report—Engagement

Review that was received following the alternative school accreditation process completed this year. The accreditation team's efforts to evaluate the three areas of Leadership Capacity, Learning Capacity and Resource Capacity were challenged by the brief number of years (2) that the school has been in operation as these reviews typically encompass a three year operational period. Practices determined to be not yet embedded to best support student academics are being embraced and addressed by the Rose administrative and instructional team. The staff were given positive feedback on their success in providing not only a sense of community and learning, but also an academic home for these students to come to.

Principal Olsen and his staff plan additional student outreach through empathy interviews to better define how best to meet the needs of this highly mobile student population.

The Board thanked Randal for his dedication to the students being served at Rose and commitment to providing needed supports for staff members who are striving to help those students realize their maximum potential.
