### **Competency-based Assessment**

The 2018 Legislature directed OSPI to review available and appropriate options for competency-based assessments that meet the state learning standards. **Dual Credit—Covering the costs of dual credit for students and families (legislative report)**The 2019 Legislature (House Bill 1109) directed OSPI to "study and make recommendations for how Washington can make dual credit enrollment cost-free to students ...within existing basic education apportionments." The report was submitted in early November and can be found here.

The report provides a high-level overview of the different types of dual credit available to Washington's students, an examination of persistent opportunity gaps, discussion of the costs of dual credit, and recommendations for eliminating costs for students and their families while increasing equitable access.

OSPI consulted with leaders in dual credit policy, instruction, transcription, and costs throughout the summer of 2019. Building from the advice and expertise of these stakeholders, OSPI developed a list of high leverage recommendations which will:

- Fully cover dual credit costs for students and their families by 2023. This includes the K–
  12 system covering all costs of exam fees for AP, IB, and Cambridge International beginning in the 2021–22 school year.
- Close opportunity gaps by eliminating policies and practices limiting access while resourcing districts to expand dual credit programming.
- Ensure dual credit counts toward postsecondary credentials.

#### **National Board Certification Renewal**

We celebrate the 802 Washington State National Board Certified Teachers who renewed their National Board Certification this last month through a rigorous analysis of their work over the past ten years in their content area professional teaching standards, and their individual impact on student learning. Though the renewal process is less time consuming than the process necessary to earn the original National Board Certification process, it still requires teachers to prove to external assessors they:

- Are committed to students and to their learning.
- Know the content they teach and how to teach that content to students.
- Manage and monitor student learning.
- Think systematically about their practice and learn from experience.

• Are members of learning communities as they support a culture of learning and growth.

Currently, nearly 15 percent of Washington state teachers are National Board Certified. Thank you to each district that offers candidate support for teachers pursuing this high and rigorous certification.

#### **Staffing Enrichment Workgroup**

Legislation passed in 2018 which directs OSPI to convene a technical workgroup, which must include representatives of diverse school districts and education stakeholders, to review the staffing enrichments to the program of basic education detailed in section 904 of <a href="Engrossed House Bill (EHB) 2242">Engrossed House Bill (EHB) 2242</a>. The Staffing Enrichment Workgroup meets Friday, November 15. The Workgroup will delve into three agenda items for that meeting:

- 1. Presentation and consideration of public feedback survey results.
- 2. Final review of the Staffing Enrichment Workgroup report of Workgroup recommendations, which is due to the legislature by December 1.
- 3. Workgroup members will participate in a conversation about advocacy for the recommendations in the report during the upcoming legislative session.

#### **Transitional Kindergarten Introductory Webinar**

Transitional Kindergarten (TK) is a kindergarten program for children not yet age five who do not have access to high-quality early learning experiences prior to kindergarten and have been deemed by a school district, through a screening process and/or other instrument(s), to be in need of additional preparation to be successful in kindergarten the following year. OSPI and the Department of Children, Youth, and Families (DCYF) will co-present a webinar to discuss the requirements of TK, where it fits in the early learning landscape, fiscal considerations, and what to consider when planning to implement TK in your school.
