PLAN A (payment in full): A deposit of \$1700 is required with the **Enrollment Contract**. By **June 1st**, the balance is due, less a discount of 5% of the total tuition amount. **The Tuition Refund Plan** is optional, but those who elect not to take it will receive no refunds for any reason.

PLAN B (3 payments): A deposit of \$1700 is required with the **Enrollment Contract**. 1/3 of the tuition is due by **June 1st**, 1/3 by **October 15th**, and 1/3 by **January 15th**. A discount of 2.5% of the total tuition amount is applied if the last installment is received by January 15th. **The Tuition Refund Plan** is mandatory.

PLAN C (10 payments): A deposit of \$1700 is required with the **Enrollment Contract**. Tuition is paid in ten (10) installments, **June 1st** through **March 15th**. **The Tuition Refund Plan** is mandatory.

A family enrolling 3 or more children will receive a discount of 20% on the third child, 25% on the fourth, and 30% on any beyond four. Discounts apply to lowest tuition amount. Tuition covers all textbooks and yearbooks. "Extended Day" service is available only for Full Day students. Enrollment forms are available in each Campus Office. We accept VISA, MasterCard, Discover Card, American Express, checks, and cash. Prices are subject to change without notice. A 1.5% Finance Charge and a \$25 Late Charge are applied to payments received five (5) days after due date.

Tuition obligations are non-refundable. Patrons understand and agree that the Student is enrolled for the entire school year, and the Patron becomes liable for the entire year's tuition upon the signing of the Enrollment Contract. If thereafter the Student is withdrawn, absent, or expelled, the School will not refund any amounts paid and the Patrons remain responsible for the entire year's tuition and fees. The Patrons further agree that the obligation to pay tuition, fees, assessments, and charges ("financial obligations") for the entire school year is unconditional and that the withdrawal of absences by the Student from Alexander School, for any reason, including illness, unsatisfactory academic progress, disciplinary suspension or expulsion, or failure to pay tuition in a timely manner, does not relieve the Patrons of the responsibility for payment of the entire year's financial obligations. Similarly, the Patrons remain solely responsible for payment of all financial obligations, regardless of whether the Patrons depend upon or anticipate other sources for funding. The Student is expected to participate actively in all aspects of school life. If, in the sole discretion of the Head of the School, the Student persistently is absent from classes, neglects work, fails to meet academic standards, exercises poor citizenship, or fails to cooperate, the Student may be asked to withdraw from the School. Cancellation under this paragraph will not relieve the Patrons of the responsibility for payment of the entire year's financial obligations.

THE TUITION REFUND PLAN is a part of the Enrollment Contract. If you have any questions regarding this policy, please call the Accounting Department at (305) 665-6274. Alexander School patrons are liable for the full tuition of the school year, or remainder thereof, when the student has been accepted for entry. Refunds for withdrawal are only available if parent has elected to use The Tuition Refund Plan. The Tuition Refund Plan is not mandatory only for patrons who choose to use Plan A. However, electing not to take the plan waives any refund for any reason. For those electing Plan A, refusal of The Tuition Refund Plan is made by initialing the box under the Plan A election. Refusal of The Tuition Refund Plan must be made in writing and presented to the Administrative Office at Red Road. Payment of The Tuition Refund Plan is due on **June 1st**, prior to the start of the school year, in conjunction with the initial tuition payment. Under The Tuition Refund Plan, a patron will receive a credit of 60% of the unused tuition (prorated on the number of class days remaining in the school year). Patrons are obligated to pay any balance remaining after this credit has been applied. The effective date of the drop is the date on which the school has received written notice of the withdrawal. If the School elects to dismiss the child, the same conditions apply. There are no refunds for short-term absences due to illness or other reasons. The Tuition Refund Plan does not cover absence, withdrawal, or dismissal for the following reasons: Riot, civil commotion, civil emergency, war, government order directed to the student or school, medical epidemic, weather, partial or total destruction of the school facility, or general economic panic or collapse.
