## SJCOE Census 2020 Update #3

### **Census Countdown: 10 weeks to Census Day (April 1, 2020)**

This week's update provides additional information to support your work towards achieving the project's purpose which is to educate, motivate, and activate students, parents, and families to engage in the 2020 Census.

These updates are written with district coordinators in mind, but you can certainly select components to share with others in your district as you deem appropriate.

#### **Census Webinar – Monday Jan. 27**

The next Census webinar will be held next week, Monday, January 27 at 1:00 via Zoom (<https://brandman.zoom.us/my/cwoozoomroom>). At that webinar we will look at the timeline for Census activities and review a sample of the census questionnaire so that you can see exactly what questions are asked on the census and how it is organized. There will also be opportunities for questions and for districts/programs to share plans for educating students, parents and families about the 2020 Census.

At this webinar we will also review the documents for reporting your district activities that are described below.

#### **Reporting Census Activities:**

Each district needs to report information related to the two required census outreach activities for each Title I school. This is the minimum requirement. Additional activities and additional schools may certainly be reported.

A spreadsheet has been created for districts to report the required information. You will find the spreadsheet in the shared Google drive (see link below). You will need to find the tab for your district. Your Title I schools have been pre-populated – with each school listed twice so that you can report the two required activities. These are the Title I schools that were included in the plan that was approved by the state so these are the schools for which we must report information. It is possible that the list is not up to date, in which case you may choose to add additional schools.

Each district may choose how to collect the information from school sites. We created a School Outreach Activity Report form (saved in the shared Google drive - see link below) that you might want to use to collect the required information and then input it from these forms into the spreadsheet.

At the January 27 webinar and the February 7 update meeting we will review the reporting forms and answer any questions you have.
