Beckman School was opened to students in 1990 and serves Kindergarten through 6th grade students on a year round schedule.

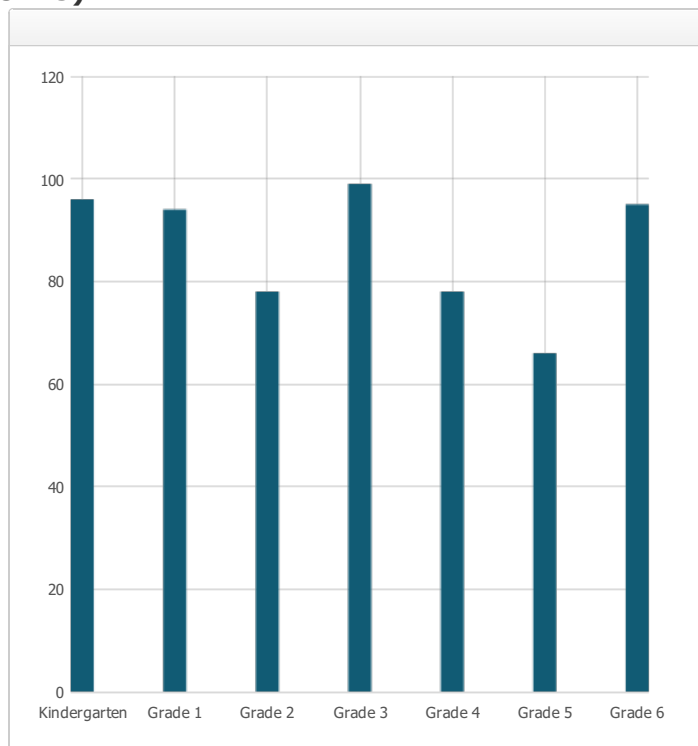

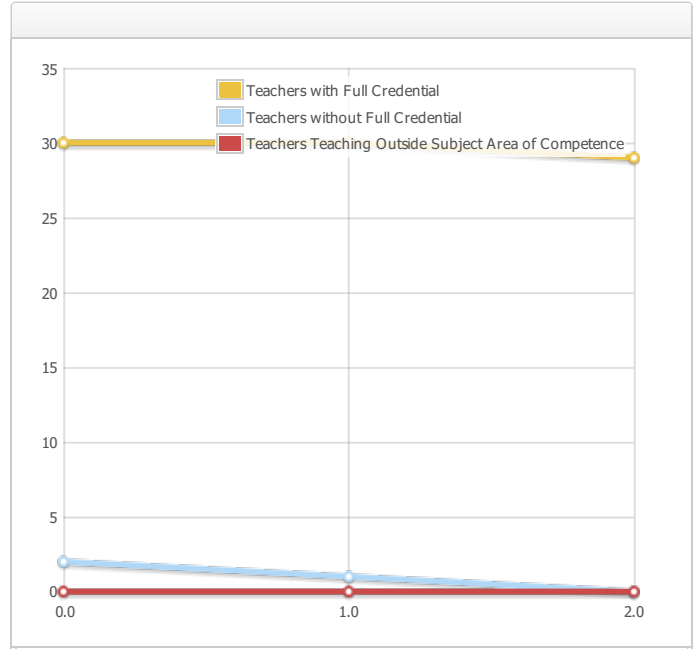

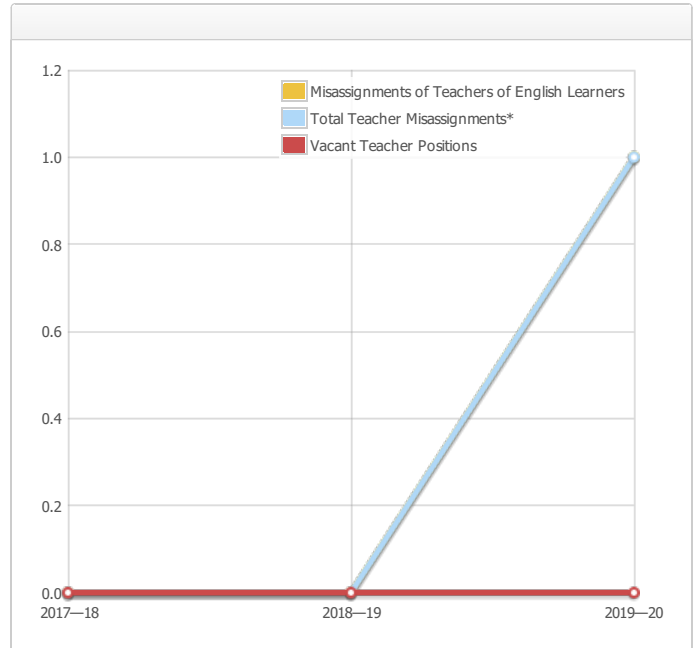

School Facility Conditions and Planned Improvements

AGE OF SCHOOL BUILDINGS:

Beckman School sits on 10 acres and was completed in 1989. Three portable classrooms were added in 1998 and 1999 for class size reduction. There are 12 total portables; one re-locatable restroom building; 14 regular classrooms; a computer lab; RSP room; library; preparatory kitchen; multi-purpose with stage and music room; administration building.

MAINTENANCE AND REPAIR:

The Beckman School facilities' condition, including grounds and restrooms, are very good based on custodial staffing, a regular district painting and maintenance schedule and funding available for equipment and supplies. Custodial workers are assigned based on a district formula to ensure equity. District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.

CLEANING PROCESS AND SCHEDULE:

A scheduled maintenance program is administered by Lodi Unified School District to ensure that all classrooms, restrooms and facilities are well-maintained and in good repair. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

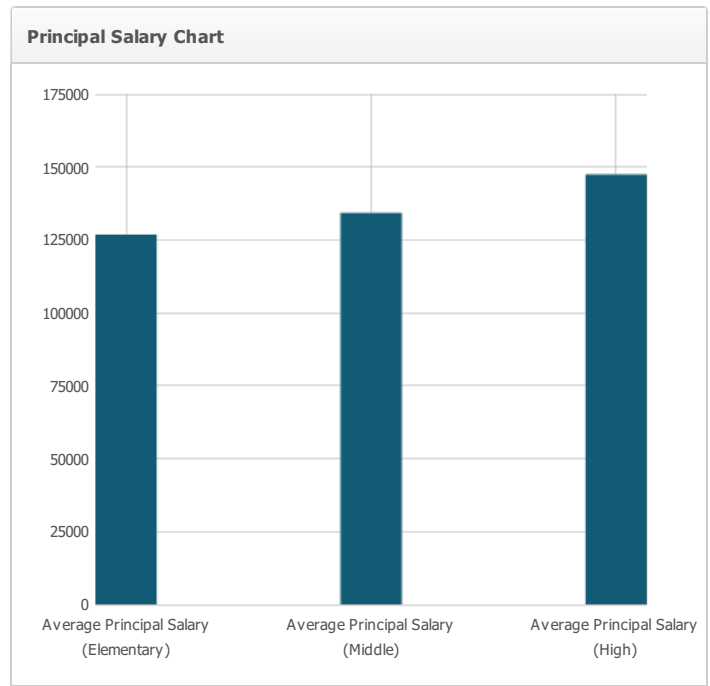
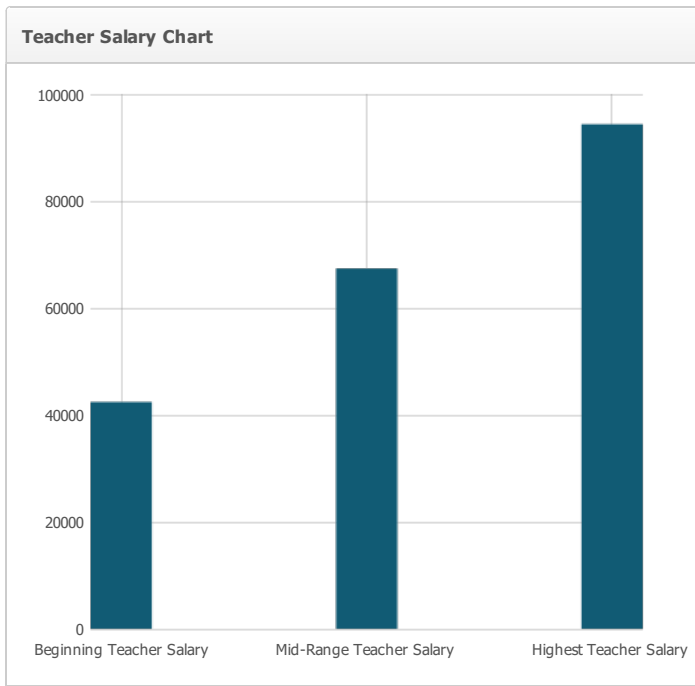
