About Measure N:

Measure N is a \$215 million school bond on the March 3, 2020 ballot to authorize repairs and upgrades for Tustin Unified school facilities. Measure N will allow Tustin Unified School District (TUSD) to upgrade outdated (1960's era) elementary and middle school classrooms; improve student safety, security and well-being; rehabilitate deteriorating roofs, plumbing, sewer, and electrical systems; renovate spaces for college and career readiness in science, math, technology, engineering, arts, and skilled trades; and add modern hands-on learning spaces and Career Technical Education labs. All Measure N funds will benefit local Tustin Unified students.

Purpose:

If voters approve Measure N, California state law requires a Citizens' Oversight Committee to be appointed by the TUSD Board of Education. The purposes of the Committee are:

- To actively monitor all projects and expenditures approved by the passage of Measure N.
- To provide proper oversight and accountability to ensure that Measure N funds are used as they were intended.
- To report to parents and members of the community on the progress of Measure N projects.

Duties:

Duties of the Committee will be to:

- Ensure Measure N funds are spent only on projects listed in the Measure N Project List and that no funds are used for salaries or general school district operating expenses.
- Monitor progress of Measure N projects.
- Receive and review copies of the annual performance and financial audits of Measure N projects as required by California state law (Proposition 39).
- Provide information to the public on the progress of Measure N projects and expenditures of bond funds.
