

Permission Slip Procedures

1. Fill out completely, have parents sign on bottom—Note deadlines on permission slips
2. Turn in to the Attendance Office
3. Once turned in to the Attendance Office it could take up to 24 hours to process
4. Must buy ticket after permission slip is processed
5. Must pay for tickets in person in the ASB Office. Do not attach checks to permission slips!
6. Must show school ID card for purchase

Guest Pass Procedures

1. Fill out completely, have all signatures required—Note deadlines on permission slips
2. Give to Guest to get signed off from their school, their administrator must attach a business card
3. Guest must attach a copy of a photo identification with birthdate
4. Live Oak student must attach (as a packet), permission slip, guest pass permission slip and photo of guest's identification
5. Turn in to the Attendance Office as a packet
6. Once turned in to the Attendance Office it could take up to three days to process.
7. Must buy tickets after permission slip is processed
8. Must pay for tickets in person in the ASB Office. Do not attach checks to permission slips!
9. Must show school ID card for purchase-**If LO Student has ASB, their guest will get ASB price**

RULES:

Please make sure your attendance is within school policy (must have a 90% attendance rate, both excused and unexcused).

1. All students and their guests must have current identification in their possession during the dance.
2. All students attending the dance with a guest must process and return a "Guest Pass."
3. Use/possession/sale of tobacco/nicotine products/paraphernalia is prohibited.
4. Use/possession/sale of drugs or alcohol is prohibited and will result in discipline from school and/or law enforcement.
5. All students and their guests must be considered citizens in good standing. The Live Oak administration has the final decision as to persons that will be allowed to attend this activity.
6. Appropriate behavior and dancing is expected. Sexually explicit and/or provocative dancing will be grounds for removal from the dance.
7. School dress code policy will be enforced. Dresses and shorts should at least reach the middle of the thigh. Attire that is overly revealing, low cut, or excessively sheer will not be allowed. Choose wisely and check with a school administrator if you are in doubt.
8. The administration makes the final decision in determining if either dress or dance behavior warrants immediate removal from the dance.
9. Guests can only be in 9th or 10th grade. No Exceptions.
