## SCHOOL HEALTH POLICIES

ABSENCE – Call the attendance line 913-993-4288 to report if your child will be tardy or absent. Phone mail is available 24 hours a day. Please call before 8:30AM. We will make every attempt to contact you in the event that we haven't received a call or prior note to verify the absence. We want to be certain that all absent children are accounted for and safe.

ILLNESS – To protect your child and to prevent illness from spreading, keep your child home if any of these contagious symptoms are present:

Temperature of 100 degrees or higher Severe sore throat, headache or cough Undiagnosed rash or skin lesions Diarrhea or vomiting Red or discharging eyes

\*\*STUDENTS MUST BE FEVER, VOMITTING, OR DIARRHEA – WITHOUT MEDICINE – FOR 24 HOURS BEFORE RETURNING TO SCHOOL

CONTAGIOUS ILLNESS – Keep your child home and notify the nurse immediately so precautionary measures may be taken for those exposed. Children diagnosed with strep throat should be on antibiotics 24 hours before returning to school.

LICE – Lice are ever present in the population at any given time. A good habit is to check your child's head weekly for lice and their nits(eggs). Please seek advice from your physician regarding treatment and remember to treat the home environment.

MEDICATION – Students MAY NOT keep medication in desks, backpacks, or pockets. ALL over-the-counter and prescription medicine should be brought directly to the school nurse and must be accompanied by the following information from both *parent and physician*.

Parent – <u>Over-the-counter medicine</u> (i.e., acetaminophen, ibuprofen, Tylenol, Advil, cough medicines, allergy medications, eye drops, throat sprays, etc) must be sent in the original container and be accompanied by written parent permission. (the OTC med form may be obtained online or in the nurse's office and must be renewed each year.)

Physician – <u>Prescription medicine</u> must be sent in the original container exhibiting a current prescription label indicating time and dosage. This will serve as the physician order.

\*FOR CONTROLLED SUBSTANCES – THE MEDICATION MUST BE HAND DELIVERED to the school nurse with a note from the parent indicating # of tablets or capsules sent (i.e., medications like Ritalin, Adderall, and Dexedrine).

INJURY – Students who have a cast, stitches, crutches, or incapacitating injury must bring a note to the school nurse from the physician or emergency room detailing any limitation in school activities.

FOOD ALLERGY – If your child has a food allergy and requires meal modifications, the form 19B may be obtained online or in the nurse's office and must be signed by a physician and parent.

EMERGENGY NUMBERS – Include a complete listing of emergency numbers where a parent/guardian can be reach in the event of illness, injury, or emergency. If there is a change in this information, call the school office so your child's records may be updated.

\*\* Please communicate any concerns or ask questions if you need clarification or further information.
