						very clear that community was a top priority as well as walkability. Map A completely fails in all these areas
						especially for our RC community. In map A, RC is moved to a new middle school without any of our neighbors
						or community coming with us. Map A requires very small number of students (~200) from RC elementary to
						move to a new middle school, FO. There are no neighboring or physical boundaries between our communities,
						which are separated by a highway and large commercial shopping area. Asking Rock Creek to leave our current
						community, integrate ourselves into an already close knit and unfamiliar community only to then rejoin our
						neighbors of the north three short years later creates clear inequity. Map A asks our kids to not only have space
						for academics and the natural challenges of middle school and high school, but to have enough energy for the
						added distraction of joining an established community. The social challenges and stressors that accompany
						joining an already close-knit community leave little energy and confidence for the academic curriculum to be a
						priority. Without additional members of our established community moving with us, our kids will have a more
						challenging time learning how to cooperate, communicate, resolve conflicts and problem solve. These skills are
						essential for success at school and finding success in academics. We don't want to leave our entire community
						and frankly it shouldn't be in the interest of the committee or school district to enforce that. I found it striking
						that so many committee members preferred map A because, at the last boundary meeting on 1/31, I heard
						multiple different committee members reference the importance of keeping communities together, specifically
						the Cedar Hills area; maps that separated this community were disliked because "community is important."
						Additionally, multiple committee members voiced concern about wanting to ensure that smaller schools were
						not affected by boundary changes that would remove a small cohort of kids and place them in a new
						community where they wouldn't know anyone (this was mentioned about a smaller elementary school in the
						southern part of the district). The irony is that map A, which was a favorite by all committee members, removes
						Rock Creek Elementary school, a VERY SMALL SCHOOL from ALL it's
						northern neighbors and moves it into a middle school that our students have no previous outside connection
						with. Additionally, our small cohort of kids would have to re-enter another established community 3 short
						years later when they start high school. At NO time during the meeting did a single committee member raise
						one concern about this, even after a representative from our community stood up and spoke raising this
						specific concern (and others) in regard to map A. And after the testimonial time, still no committee member
						mentioned this as a concern for our school; however, many rejected other maps due to this same concern for
						other schools in the district. This is unacceptable. I am raising this concern as I know so many other parents
						have OVER and OVER; this is not acceptable. Please hear us. Map C is a map that supports the RC community and
						our priorities. Map C provides consistent community for Rock Creek kids that progresses from elementary
						school through high school together while being able to still meet and integrate with other communities. Map
1						C also provides improved socioeconomics for FO middle school, more than just moving RC independently, and
						helps to improve equity throughout the district. Map C maintains portions of our community which is a huge
1						priority. However, in map C, our small Rock Creek community is again separated which again does not support
1						our community staying together. Map C aims to prioritize walkability; however, this is not a priority for our
						community as there is no middle school close enough to walk to. Therefore, why separate us. In keeping the RC
						community together our kids benefit. Positive friendships relate to student's success in school and provides a
						more stable learning environment. Kids learn cooperation, problem solving, conflict resolution and
						communication when they have the support of their friends. Map C (keeping the whole RC community
						together) reduces the split feeder pattern from middle school to high school and most middle schools are kept
1						at two high school splits. Limiting feeders enhances strong communication and alignment of practices between
1						middle and high school. There are fewer disruptions and distractions in students' education when they
1						transition into and out of new communities and schools alongside friends. Although walkability is not as
1						important for RC elementary, I recognize it is important in other communities and map C optimizes this and
1						saves on additional transportation fees. Socioeconomic diversity and academic equality are more balanced
1						across the district with map C specifically decreasing the free and reduced lunch percentages in the 3 middles
						schools that currently have the highest rates. Map C and B are the maps as a RC parent I can support and

However map C still had Stoller at 100% in 2021 and 106% in 2025. One interesting observation is that the western most part of the stoller boundary has a portion of Springville kids. Looking at the Projected 6-8th Grade Residents by Grid Code in 2021 (https://v3.boardbook.org/Public/PublicItemDownload.aspx?ik=45745552) there are 71 kids in that area and 75 kids in 2025 (https://v3.boardbook.org/Public/PublicItemDownload.aspx?ik=45745560). These kids are being separated from their friends in Springville so moving them to Five Oaks with Springville will keep them together. This would also bring Stoller totals in 2021 from 1078 (100%) to 1009 (93%) and 2025 numbers from 1150 (106%) to 1075 (100%). The problem in 2014 was the growth of Springville resulting in the overcrowding of Stoller. In 2020, we are still battling the same problem. From the Oregonian (Nov 2014) – "Springville and Stoller are being squeezed by the rapid rise of housing developments in North Bethany. Springville saw its enrollment jump by more than 100 students this fall. Stoller, which was already beyond capacity, received about 58 additional students." Back in 2014, the then Superintendent Rose along with Stoller's Principal Florence Richey made a public statement to Stoller parents in her Nov. 19 newsletter, about their decision to not ship its Summa program off to the future middle school in Timberland area of Cedar Mill. Instead, Stoller converted some of its four computer labs into classrooms to keep those SUMMA students along with their resident friends on the same campus. The Oregonian also specifically cited- "When the new middle school opened, it would have a Summa program and Stoller would start its program again." 
On behalf of the entire Jacob Wismer community, we would like to thank you for taking out time of your busy schedule to talk to us at our February 3rd PTO meeting.

As a community, we have been engaged in the boundary adjustment process and have followed the discussions closely. However, it was very helpful to get a comprehensive view from you directly. For example, it was interesting to learn why building a middle school (or any school for that matter) is not as easy as it seems. Information about building just a single school being an extensive process with layers of approval and humongous financial needs definitely helped us connect dots and brought clarity to some areas of our thought process. It was also good to get clarification that any high school and elementary school changes being considered, will be separate from the current middle school boundary adjustment process.

The core team at JW has come up with a few points that we would like to share with you, and we hope that you, your team, Mr. Beaver and the Advisory Committee find this useful.

1) Thank you for validating the route transportation times for Springville to Five Oaks via parallel bus runs and posting it. There has been much speculation and several heated conversations on social media which the new data should hopefully put to rest. The entire committee should be made aware that the travel time from Springville to Five Oaks is only about 20minutes one-way from first pickup to MS drop off. The handout from the last meeting was a little ambiguous in terms of whether it was one-way or round-trip data. In addition, misleading comments posted by some people in the community claiming their children would be in buses for up to two hours may confuse committee members since it obfuscates the truth.

Upon analysis of the transportation data provided by Mr. Beaver on 01/30/2020, **the longest route for Springville will only take at most 2 minutes longer to Five Oaks than to Stoller**. We also noticed that the farthest Findley population would also be traveling just as long to get to Timberland as Springville to Five Oaks.





2) We recommend that you remind the entire community that there are no plans for another middle school being built, given that there is enough space in the existing district schools to accommodate all the children in the district, even in 2025. Transporting children to the nearest schools with space will become the norm, until the district's population outgrows the capacity.

It would help to have the community understand that based on the results from the recent seismic tests conducted by BSD where many schools were highlighted as needing high priority seismic upgrades, meeting those safety needs takes priority over building new schools in the coming years. We believe that every parent in every community would see the sense in that and be able to stand up for our children, teachers, and staff's safety.

- 3) Currently, Map A on the table for discussion suggests the following:
  - a. Segregation of two diverse neighborhoods south of Springville ES to feed to Five Oaks, while the rest of Springville goes to Stoller. This is extremely unfair to those two communities (totaling 71 students in 2021 projected numbers) that will be going to Five Oaks, as it will result in the already socio-economically diverse Five Oaks Middle School to be even more diverse, simultaneously taking away the opportunity to spread some socio-economic diversity to Stoller Middle School.
  - b. SUMMA be relocated to Timberland while Springville be bus-ed to Stoller. If adding routes to transport the currently walking majority of Stoller SUMMA children to Timberland is more cost effective than funding the longer Springville routes to proposed MS (please provide the data to go with this scenario, currently SPV students are already on a bus), then we believe that the district should favor that decision.

Both of the above aspects of Map A are unwarranted and most importantly, at the rate Sato and Springville are growing, within a couple of years, Stoller will be overpopulated once again bringing us back to where we stand today! (with no new middle school in sight for relief).


Map A puts Stoller way over capacity, even without Summa or the south portion of Springville split out to Five Oaks. *The total number of students from Springville and Sato alone exceeds the capacity of Stoller by 2025,* while the population of Jacob Wismer and Findley schools are stable or even declining- as you can see from the graph above. This time and again validates our biggest conviction: two growing communities like Springville and Sato cannot feed Stoller Middle School.

4) We acknowledge that SUMMA is an optional program. However, ~45% of the current SUMMA population of Stoller lies within the proximity/accessibility zones (100% of Jacob Wismer is within the Stoller walking boundaries). Map C only improves this more by taking it to 65% (151 of 233 kids are proximally placed). Both these percentages are staggering and hopefully speak to the Committee members and the District Officials.

Map A moves the entire SUMMA to Timberland which is not a long-term solution to accommodate Springville at Stoller. Moving all the SUMMA kids out will not create sufficient space to accommodate SPV, which is the main argument from SPV community.

Please provide us with the transportation costs to transport these current 151 students from within walking zones to newly proposed MS locations. Even though other option schools are placed based on space availability, it seems logical that given the opportunity to maintain SUMMA at Stoller; the district would move in that direction - not because the district is prioritizing an option school over feeder schools, but because it makes economic sense! Every family has to budget and make difficult choices between available options; and at the end of the day, it usually boils down to the available funds and opportunity cost. This is no different.





5) Finally, we would like to request the committee to consider the possibility that SUMMA qualified children may opt out of the program, due to logistical issues for working parents and simply revert back to their feeder middle school, Stoller MS. In this scenario, Stoller will have an overcrowding issue much sooner than in a couple of years. Chances are that most children that qualify for SUMMA will enroll and attend the SUMMA program. However, even if 20% of the projected SUMMA children opt out of the program, it will only make the issue at Stoller even bigger. Hence, this possibility must certainly be considered to avoid being blindsided, after decisions have been locked in place.
