## OPENING EXERCISES

Ms. Shawna Keller, president of the Board of Education, called the meeting to order and declared that a quorum of the board was present; therefore, the meeting was qualified to consider the agenda items. ## STAFF REPORT

Chief Operations Officer Jorge Robles presented a *2019-2020 Start of Schools* report, and he shared pictures of recent bond projects. Chief Robles, members of the Board, and Superintendent Gist thanked Team Tulsa members who had worked to make a successful, safe opening of school for the students and staff.

## BOARD MEMBER REPORTS

Board Member Hosmer reported that he had the honor of speaking to Ms. Erin Parker's Native American Literature class at Edison Preparatory Middle School the previous week. He commended Ms. Parker for her work and dedication to the district's students.

Board Member Marshall reported that she recently had the opportunity to participate in a three-person panel discussion with ninth-grade students at Tulsa Learning Academy. She commended the students and school leadership for their outstanding questions and discussion topics.

Board Member Wester thanked the community and staff members for their active participation in recent budget redesign community meetings. She commended their commitment, support, and dedication to the budget redesign process.

Ms. Wester also gave a brief report from a recent Teaching and Learning Committee meeting where committee members were briefed on the district's Tulsa Way for Teaching and Learning



module. She said that the committee also reviewed the timeline for the English Learners Success Plan.

Board Member Woolley thanked staff members for their sacrifice of time and talents during the budget redesign work and the many community meetings.

President Keller also commended staff members for the budget redesign work, and she announced that the next community workshops would be held on October 8 at Central High School and October 10 at East Central High School. Ms. Keller also reminded board members of the upcoming OSSBA Region 4 meeting where board members would have the opportunity to earn required continuing education credits.

#### SUPERINTENDENT'S REPORTS/PRESENTATIONS

Superintendent Gist announced that two Central High School pom students had been invited to perform at the Macy's Thanksgiving Day Parade, but they needed funding in order to participate. #### ANNOUNCEMENTS


