## Goal 3 continued

To work on this goal, we have chosen the following instructional strategies that are culturally responsive, high leverage, and adhere to universal design for learning. These strategies will be used in Arrowhead's classrooms and throughout all learning environments. These strategies we have chosen are based on best practices and have been shown to make a positive impact on student learning.

- Piloting new NSD ELA curriculum in grade 3 (one classroom piloting Grade 2)
- Implementation of Phono-Graphix by all Special Education Staff
- Year-long PD on building relationships and cooperative learning strategies in line with district strategic plan
- Collaboration with Special Services and ELL and LAP to ensure consistency with instruction and monitoring of growth
- Partnering with parents on student literacy growth by aligning milestone dates with parent conferences and progress reports
- Ensuring that students can see themselves in classroom materials

## Facilities

Our school was built in 1957, giving it a long-standing history in the Arrowhead community. We've undergone both major and minor renovations. Our gym floors were refinished and the entire heating and ventilation system and roof were recently replaced. Each classroom has an interactive white board, projector, document camera and sound system to meet the needs of both pupils and staff. Our students benefit educationally from two outdoor, natural garden habitat areas. In addition, Arrowhead students enjoy a variety of options for play on school grounds.
