Gifts in Wills are a tax-efficient way of helping Millfield create opportunities for young people. Because Millfield is a charity, legacies are exempt from inheritance tax at 40%, and will reduce the rate of inheritance tax on the remainder of your estate to 36% if you give

more than 10% of your net estate to charity.
