I know that serving the community in any capacity is challenging, and often thankless. I would like to take the opportunity to express my support for the Map A MS boundaries proposal. The case for Map A, from my point of view, is the critical need to establish MS boundaries that: 1) provide the strongest social structure and community for the students entering HS that sets them up for success; 2) maintaining the current, and now accepted, HS boundaries; and 3) make the most geographical sense, thus minimizing family disruption, keeping transportation costs down, and minimizing the time students are in transit. On point 1, Map A will ensure that Oak Hills ES children enter their HS years with kids that attended their MS. However, Map C does just the opposite. At such a critical time, when children are figuring out who they are and how they belong, the social networks they establish can play a crucial part in their scholastic success. Thus, choices for MS boundaries should take into account the downstream impact this will have when children leave MS and start HS, particularly when one plan (Map C) has children attending HS with students almost exclusively from other MS.On point 2, Map A keeps the HS boundaries the same, which is essential for stability for our children and families. The last HS boundary changes resulted in significant disruption for many, splitting some communities between different HS. An additional change in HS boundaries so soon after the most recent changes is an undue burden on students, families and their communities.On point 3, the geographical maps should make sense, both from the standpoint of minimizing transit times for students and limiting disruption to parents that are required to transport their children. This relieves Stoller and fills Timberland - the main objectives of this process - and avoids splitting yet another school. It also treats SUMMA students as resident students for their neighborhood school I know there is (exaggerated) concern for the Sunset-feeding kids at Jacob Wismer, but let's be honest. This scenario does not compare to the 20-25 kids from Oak Hills. Jacob Wismer Sunset kids have approx 200 students that will be together from elementary to high school. Realistically, how many friends/classmates does an 8th grader know? I doubt that it is close to 200. My 5th grader can't name half of the kids in his 100 student class. Transitioning to high school with 200 kids from the same school is definitely sufficient I also ask: why are we creating unnecessary school splits in the north when the priority has been to reunite the split schools in the south? I value walkability as much as anyone, but it is obvious that including the walkable portion of Findley in Stoller forces many other schools to be split in order for them to fit, tearing communities apart. Findley is the closest Stoller school to Timberland. If it is okay to bus walkable SUMMA students from Sato and Jacob Wismer to Timberland, then that is also true of all walkable students from Findley. If SUMMA is bused to Timberland, then that is also true of all walkable area of Findley (the highest concentration of SUMMA), so it is logical and definitely not a hardship to take all of those Findley students on the same buses to Timberland. ----Original Message-----

My name is Emily Walker and I'm the Springville parent of four kids that you heard from tonight. I know I already had my two mins in front of the committee but my nerves and time constraint got in the way of some other things that I didn't get to say. So I hope this is a good way to say some of the things I left out. I can't seem to sleep unless I get this all off my chest!

I understand that your job is hard, time consuming, and there is just no possible way to make everyone happy. But if Springville gets moved to Five Oaks this would be breaking up such a strong community we have worked so hard to build.

From talking with other Springville parents, I think one of your first problems would be adding to the already horrible traffic problems on 185th. Many parents would choose not to send their child on such a long bus ride over to Five Oaks and therefore choose to drive them, or put them in private schools. With the tremendous growth happening in our neighborhood this would dramatically add to the mess that already is 185th. I know you will say well that's the parents choice to drive them, but what about the traffic impacts that will cause? Will the city have to step in and spend tax dollars on road maintenance and widening projects to accommodate all the added cars? What are all the ripple effects of all that added traffic? More people on the road usually equals more accidents, pollution, congestion, etc. Nobody wants that. And you can bet on a large majority of parents not letting their kids ride the bus. I know it's not a hard fact but take a survey of Springville parents and ask them! I know at least half would choose to drive their child over making them ride the bus, and many would even take their kids out of public schools all together.

As a side note, I'm wondering how 22 minutes was chosen for the travel time from Springville to Five Oaks? I drive that route twice a week right after school gets out to take my daughter to dance class very close to Five Oaks and it takes me 35 sometimes 40 minutes with all the traffic. I can't imagine how long the bus ride will be with all the added bus stops too!?! My 7th grader now at Stoller has a 10-12 minute bus ride and that is long enough. The noise and foul language he hears on the bus is horrible, but I unfortunately don't have the choice to drive him because of my job constraints.

Secondly, our kids would lose that sense of community. Generally speaking, your friends with those that live close in proximity to you when you are younger and don't have the driving freedoms that older kids and adults have. So if you move us to Five Oaks, all our Springville kids are going to know hardly anyone else except those from Springville. We are an island on Map C like I mentioned tonight already because of PCC Rock Creek and how far north we are from all the other elementary schools that feed into Five Oaks.

Lastly, Five Oaks feeds into AHS and WHS, once again splitting our kids off from friends after 8th grade but this time to Aloha which is even farther from Westview. I realize that Stoller where they go now feeds into Sunset and Westview but at least Sunset is much closer. My 16yr old son at WHS is still very close with his Stoller buddies that go to Sunset because they don't geographically live that far away from us. I really think it would be disastrous for our kids and our community. There has to be another way to keep us with those schools surrounding us. Please look again at Map A and think about the negative ripple effects of Map C.
