As a graduate of Five Oaks and Westview I have fought for my belief in public education and the BSD to a husband who was a Portland private school graduate. At this rate I just might shift my opinion as the district is not hearing the voices of my community. I am very aware of the district shuffle throughout the years. The issues are not new and the planning for the future was clearly poor. I have been a student in the shuffle in the 90's in BSD, and the ripple is real.Now down to business:It was clear in the meeting held at Oak Hills today that because our small community is not as loud as other larger communities (double the size of us, or at least willing to skirt the rules of engagement) that we are not being heard. In learning about the new map to be released we have been reduced to the "East Oak Hills" parents fighting for our kids and yet getting smaller and less heard. The division put upon our community is taking a toll on things we had not imagined. This seems similar to the feeling our kids will encounter with the path this boundary change is putting them on. A small and voiceless group who is overhauled by the bigger communities and gets lost in the shuffle or asked to make accommodations. Sounds just like the scenario our kids will go through. The process of the isolated transitions with limited peers form MS to HS, is impactful to their wellbeing. We are unheard and they are unheard. PLEASE give our kids a chance to not be isolated. It seems clear the new maps direction. PLEASE consider sending our east OH kids to Timberland so that they have a group, a voice, a place to belong on a long term path. Moving less than 25 (if that many after kids head to option schools) kids from Meadow to Timberland will not change the enrollment at Meadow in any way but positively. And from my understanding balancing enrollment is the 3rd initiative of this committee. This helps balance positively and helps our kids social and emotional status. Although it was made clear in our meeting today that this criteria had no value in the decision making process. I implore you to consider this option and that the social and emotional health of our students leads to better markers in all the categories the district is actually tracking. Given all facts, in order to satisfy the goals of 1. Reduce overcrowding at Stoller. 2. Better Middle-High School feeder pattern. 3. Socio-economic equity. 4. Prioritizing walkability for neighborhood kids. 5. Balance out the issue of district space availability in south but crowding in the south. The best option for Stoller will be to keep all of Jacob Wismer and Sato and possibly walkable portion of Findley - This will keep the walkability goal intact. Also by combining a stable (JW) with growing (Sato), a good density will be achieved. Also, it is important to keep Summa program at Stoller. This could include Summa kids from JW, Sato and Springville (Summa only). Given the pattern of density of Summa students from JW and Findley, this makes the most sense. While our kids may not be in the same class room, school, or even neighborhood, the fact is, we may very well cross paths during extracurricular activities, sports, or other community events. Let's keep it real and not manipulate numbers, bus ride times, walkability status, etc. to get what we want. While none of the maps posted is ideal; for anyone, I'll reiterate that I think the goal should be to relieve overcrowding while creating equity within the school system. 							<p>Hello Boundaries Committee,I want to thank you for reading all of these comments, and for the hard work you have put in during this process.In the priorities for redrawing boundaries, equity is the most important issue to be considered. Mountain View Middle School is currently carrying a very large share of low income students who are on free or reduced lunch. This is a *big* burden for a school to carry. As we look at boundaries, I want to be sure the boundaries for Mountain View Middle School are considered, and that the boundaries are drawn to be more equitable, which would benefit all students. Currently, Mountain View Middle School has 61% free and reduced lunch students.(https://www.ode.state.or.us/data/reportcard/reports.aspx?id&#61;1183).This is almost double the district average of 36% (https://www.ode.state.or.us/data/reportcard/reports.aspx?id&#61;2243)There is not even one Beaverton School District Grade 6-8 Middle School that has a higher rate of free/ reduced lunch students than Mountain View Middle!! This problem of inequality and equity needs to be addressed. One way to alleviate this concentration of poverty would be to change boundaries so that all of Cooper Mountain Elementary, which has 18% free and reduced lunch (https://www.ode.state.or.us/data/reportcard/reports.aspx?id&#61;1160) would go to Mountain View Middle School.The students from Chehalem Elementary, which currently has 64% free or reduced lunch (https://www.ode.state.or.us/data/reportcard/reports.aspx?id&#61;1159) could be moved to Highland Park Middle school, which currently has 31% free or reduced lunch (https://www.ode.state.or.us/data/reportcard/reports.aspx?id&#61;1184) .This simple swap of students - moving Cooper Mountain Elementary to Mountain View middle, and moving Chehalem Elementary to Highland Park Middle - would alleviate the pressures of poverty at Mountain View Middle School. Mountain View Middle School currently has the lowest number of students meeting math and Language arts state standards (https://docs.google.com/presentation/d/1M9N1YifUCPNcZxPangjc1bA0k4-n7A9sSlcl7fjrlr4/edit?usp&#61;sharing) . This is *NOT* because Mountain View is a &#34;bad school&#34;; but because they are shouldering a *MUCH* larger portion of low income students than most other district middle schools. You really have an opportunity here to help fix things for Mountain View Middle.Please consider making these changes so that there is not as large of a concentration of poverty at Mountain View Middle.Thank you.Carrie</p>

The district completely disregarded our community connections when the high school boundary lines were redrawn and now it seems as if our kids are getting the short end of the stick once again. Westview receives 24% of its students from Five Oaks and 23% of its students from Meadow Park. There are clearly many examples of middle school feeders accounting for 24% or LESS of the student population within a high school. With Jacob Wismer feeding from Stoller to Sunset (not including their additional Summa students attending Summa outside Stoller), they would account for 18.5-25% of the population at Sunset High School. At a MINIMUM, 18.5% of Sunset would be Stoller (Jacob Wismer) students. Ideally the very small portion of Westview feeding Jacob Wismer students would be rezoned to Sunset (Sunset DOES have the permanent capacity to withstand this minor adjustment), in which case 25% of the population at Sunset would be from Stoller/Jacob Wismer. Additionally, it is also most cost effective.Starting the utilization of permanent capacity, according to "Basic Summary Table A_C_2.X_02.13.20.pdf", both "Original Workmap A" and "Original Workmap C" address the immediate 2021 and project 2025 capacity issue and has the highest utilization cap at < 110%. "Original Workmap A" presents a more balanced utilization for the North BSD zones, as the utilization percentages are at 104/93%/85%/83%/88% for CedarPark/FiveOaks/MeadowPark/Stoller/Timerland. On the other hand, the utilization percentages of "Original Workmap C" are at 87%/90%/104%/100%/74%, which clearly shows that Timberland MS is under-utilized. Similar conclusion can be drawn for proj 2025 utilization percentages.Regarding the AM/PM ride time, "Original Workmap A" is also more balanced than "Original Workmap C". Based on the tables from "SPV-FIN-RCK Rider-Miles-Times_REV_02.07.20.pdf", students from Springville ES and Findley ES will spend on average 16min/14min traveling to Stoller MS and Timerland MS respectively in "Original Workmap A". These students will, however, spend 21min/12min respectively if they are to be sent to Five Oaks MS/Stoller MS according to "Original Workmap C". Adopting "Original Workmap C" clearly would be a loss in children's time for the society overall.From the same "SPV-FIN-RCK Rider-Miles-Times_REV_02.07.20.pdf", it is furthermore clear that "Original Workmap A" is more fiscally and environmentally responsible for BSD, compare to "Original Workmap C". The bus route cost for "Original Workmap A" is \$61,229 while the cost for "Original Workmap C" is \$78,525. This is a significant difference of \$17,296, which BSD should consider translating into additional carbon emission resulted.From early meeting material (e.g. December 19 AC Report.pdf), the committee was recommended to use the follow Policy JC Factors to evaluate the boundary proposals. 

Thank you for coming to the Oak Hills PTO meeting this afternoon. I wish that I could have attended, but my own students don't leave my classroom until 3:05pm.

I know that you heard this from other parents, but I want to make sure a change for the students on the east side of Bethany is made in the next iteration of the map. We need a feeder pattern that sends us to a middle school with a majority of Sunset-bound students.

The current situation, and many of the maps that have been considered, leaves us at a middle school where most students are headed to Westview or Beaverton. My freshman daughter headed to Sunset this year from Meadow Park, leaving virtually all of the middle school friends she made behind as they headed to other schools. Before school started, we could only identify 2 students that she knew that she knew had the same lunch period. Two. I can't imagine walking into a cafeteria of over 1,000 students and only knowing 2 other kids. She has been working hard to make new friends through sports, clubs, and classes, but it is hard to be an outsider. And nobody should be an outsider at their home high school, when they have lived in the same house for 14 years.

I know you can't fix this for her, but please use this middle school boundary process to fix this situation for our younger daughter, and for all future Oak Hills kids. Please send our side of Bethany to a middle school where a majority of students are Sunset-bound. If our closest Sunset-bound neighbors (Terra Linda and Bonny Slope) are headed to Timberland, then we ask to go with them.

Our children deserve the chance to build community and establish relationships that they can carry into high school. We are a small group, but please hear our voices and do the right thing for our kids.

I know your inbox is being swarmed with emails due to the middle school boundary adjustment but I did want to voice my opinion with some past info and with an understanding our projected numbers. This is a differing opinion of many of my Oak Hills parents from the Eastside.

I have three kids at Oak Hills Elementary school and I live on the Westside of Bethany. I do know many Eastside parents of Oak Hills are begging to join Timberland and split with us because they don't want to go to Meadow. There reasons are: they will be the only students from Meadow to go to Sunset- which is false as we know, Barnes also goes there.

I really want to see all of Oak Hills stay together (we were already split with the high school boundaries). If Bethany and Oak Hills and Barnes all go to Meadow, we will evenly split between the two high schools. There is zero reason to switch. If we do, Barnes, an already under represented school will be alone at Sunset.

If we do split, it could cause future complications when Westview gets bigger and bigger. If by chance we need to move students from Westview, it would be easier to move Westside Oak Hills to Sunset.
