Immunization Requirements for Pre-Kindergarten Students

Important: On 6/13/19, NYS eliminated the religious exemption from vaccinations for school attendance. Information is available on the NYS Department of Health website at:

Dear Parent/Guardian,

New York State Law Section 2164 requires certain immunizations (shots) to enter **Pre-kindergarten** and attend school. Please check with your health care provider as soon as possible to make sure that your child has all the needed immunizations.

Required Immunizations for Pre-Kindergarten

Immunization	Number of Doses
Polio	3
Hepatitis B	3
Diphtheria/Tetanus/Pertussis	4
Measles/Mumps/Rubella	1
Varicella (Chickenpox)	1
Hemophilus Influenzae	1 to 4
Pneumococcal Conjugate	1 to 4
MEDICAL EXEMPTIONS	UPDATED ANNUALLY at the BEGINNING OF SCHOOL YEAR

Proof of immunization should be sent to the school nurse **WITHIN 14 days of the start of school** where your child will be attending. **EXCLUSION DATE**

Proof of immunization must be **any 1 of the 3** items listed below:

- An immunization certificate signed by your healthcare provider
- Immunization Registry report (NYSIIS or CIR from NYC) from your healthcare provider or your county health department
- A blood test (titer) lab report that proves your child is immune to the diseases
 - For varicella (chickenpox), a note from your healthcare provider (MD, NP, PA) which says your child had the disease is also acceptable.

If you have questions/concerns about immunizations, please contact your healthcare provider.
