



Seattle Prep Morning Shuttle Program 2019-20

Seattle Prep is pleased to continue offering morning-only van transportation from North Seattle, West Seattle, South Seattle and the Eastside to our families. The yearly cost (**includes** \$100 non-refundable deposit) is \$770 for the North Seattle, West Seattle, South Seattle routes and \$870 for the Eastside route. Payment options include paying the entire amount **OR** making 4 payments that are due on a quarterly basis (see Payment Options below). The \$100 deposit is paid separately with the completed contract. A limited amount of assistance is available for students who qualify. Contact Sue Dmitriev for information regarding transportation assistance. Student shuttles run each morning, including late starts, half-days and testing days.
