WHEREAS, the SEQRA Regulations declare Type II Actions to be actions that have no significant impact on the environment and require no further review under SEQRA; and

WHEREAS, the Harrison Central School District as the only involved agency, has examined all information related to the capital improvement project and has determined that said capital improvement, including modifications, replacement, upgrades and repairs to such building components, systems and spaces as: Security Vestibule Addition at the Harrison High School are classified as a Type II Action pursuant to Section 617.5(2), (8) of the SEQRA Regulations;

NOW, THEREFORE, BE IT RESOLVED that the Harrison Central School District hereby declares itself lead agency in connection with the requirements of the State Environmental Quality Review Act; and

BE IT FURTHER RESOVED that the Harrison Central School District hereby declares that the capital improvement project including modifications, replacement, upgrades and repairs to such building components, systems and spaces as: Security Vestibule Addition, at the Harrison High School, are a Type II Action, which requires no further review under SEQRA; and
