Good morning!

I wanted to take a few minutes and send you the attached document. This document has two separate BSD documents super-imposed to give the consolidated picture of District poverty heat map vs. District SUMMA heat map.

It's a very simple document to understand that SUMMA has definite linkage to Wealthier and Elite neighborhoods.

Given this analysis: there's two concerns here -

- 1) BSD commitment to Equity is challenged by SUMMA concentration amongst those neighborhoods that are very affluent, and this implies that BSD is spending an good chunk of their learning and development budget that favors only a small minority of wealthy students in the district. Based on heat map, almost negligible SUMMA population is from the poverty areas, which means SUMMA program is not equitable to those in the district that are within the poverty zone or those dependent on Free and Reduced Lunch option.
- 2) Based on the attached document It's clear to see that largest two populations of SUMMA are from the Findley and Jacob Wismer schools which are amongst the wealthier neighborhoods in all of BSD. This is not to take away from the kids that are gifted but this also raises a valid question how's it possible that two schools have consistently managed to crack the SUMMA entry level testing? Is there any additional help being provided to the students in these schools by parents putting the kids through expensive external coaching classes to crack the SUMMA testing?

Does BSD have any research that can be made public why only these two schools account for such large numbers of SUMMA qualified candidates?

Are there any BSD policies around expensive SUMMA entrance coaching opportunities being provided largely by the affluent families whereas their peers from poverty areas are deprived of any such additional coaching opportunities.

Lastly, the concerns are around the undue influence that JW AC member is advocating for SUMMA during the Boundary committee meetings. It has been noted that a disproportionate amount of discussions have happened about SUMMA students that are less than 4% of total BSD middle population but the majority of discussions have been spun around SUMMA. This is putting the remainder of 96% of BSD regular education students at a distinct disadvantage.



Summa concentrations and areas of increased poverty are mutually exclusive
