Furthermore please note Stoller is the largest middle school with large portable capacity. Aiming 100pct for Stoller in 2025 although sounds wise yet it is not completely necessary. Just look at how many student it is housing today at Stoller 160pct although crowded I did not hear major teacher to student ratio that would otherwise affect student performance. Stoller students are receiving great education every day. On the other hand FiveOak is not expandable due to landscape it cannot and will never have portable capacity ever. The school is already overcrowded and unless you introduce major disruption to FiveOak such as moving AHP to Mountainview or major FiveOak turnover, FiveOak is not going to be able to absorb any Bethany schools in any sustainable way because FiveOak has a capacity that is fixed. Also transportation from Bethany area to FiveOak is a huge concern for safety due to the high accident rates on 185th. Please think through all the map scenarios with caring for kids in mind when you suggest a change to the current Feb25 work map which many people think it is great as is and meeting most of the public consensus and projections by the PSU studies.

Cedar Park would receive SUMMA and could absorb some portion of Summa from Whitford to reduce Whitford overpopulation and bolster Cedar Park population. Five Oaks will become a 100% Westview feeder and the portions of Springville and Rock Creek removed from Stoller will be moved to an academically acceptable alternative. Since Five Oaks is the closest school other than Stoller to both Springville and Rock Creek, no undue or expensive travel is required. After reviewing the public testimonies from all elementary schools at the February 25th meeting, I've summarized their main concerns and came up with tweaks to the existing map. This proposal will address the main objectives of this committee: (1) address the Stoller overcrowding issue due to future Sato construction and (2) filling Timberland to it's capacity.

Can you please forward these slides to the committee and also make this as my public comment? I certainly hope that the committee takes time in digesting this and keeping their minds open to this proposal. As what one committee member said, we cannot fit all the jigsaw puzzle together since these aren't made to fit. 



 - ▶ **Forecasted** Sato growth due to future construction
- ▶ There's still space at Timberland. 80%
- ▶ Cedar Park underutilized at 80%
- ▶ Splits middle school kids going to high school
 - ▶ Jacob Wismer non-Summa kids.
 - ▶ About 100 Grade 8s at Stoller will go to Sunset.
 - ▶ The rest of Stoller (1000+ kids) goes to Westview
 - ▶ East Oak Hills
 - ▶ About 20 Grade 8s at Meadow Park will go to Sunset.


Step 1: South Barnes to Cedar Park

- ▶ South Barnes is right next to Cedar Park walkability zone.
- ▶ Move Meadow Park Dual Language program to Cedar Park
- ▶ Grade 8 DLLs will then go to Beaverton HS
- ▶ Cedar Park Permanent Capacity Utilization
 - ▶ 2021: $812 / 872 = 93\%$
 - ▶ 2025: $794 / 872 = 91\%$




Step 2: Terra Linda to Meadow Park

- ▶ East Oak Hills and Terra Linda are sister communities
- ▶ Both are in proximity to Meadow Park
- ▶ Continue SUMMA for Five Oaks, Cedar Park, and Meadow Park
- ▶ Meadow Park Permanent Capacity Utilization
 - ▶ 2021: $977 / 855 = 114\%$
 - ▶ 2025: $862 / 855 = 104\%$
- ▶ Recommend BSD to keep existing portables at Meadow Park
 - ▶ 2021: $977 / 939 = 104\%$
 - ▶ 2025: $862 / 939 = 91.8\%$



Step 3: Jacob Wismer at Timberland


- ▶ Keeps JW (Summa/non-Summa) together in Timberland up to Sunset HS
- ▶ Keeps Springville and Sato together
- ▶ Makes room for future Sato growth
- ▶ Keeps Stoller SUMMA within new attendance boundary
 - ▶ All SUMMA / non-SUMMA Grade 8s will go together at Westview
- ▶ Stoller portables may not be needed.
- ▶ Stoller Permanent Capacity Utilization
 - ▶ 2021: $802 / 1081 = 75\%$
 - ▶ 2025: $1102 / 1081 = 1.02\%$
- ▶ Timberland Permanent Capacity Utilization
 - ▶ 2021: $1194 / 1100 = 108\%$
 - ▶ 2025: $1153 / 1100 = 104\%$



Summary

- ▶ Keeps Communities and Dual Language intact.
- ▶ Reasonable splits with no isolations.
- ▶ Sustainable solution for Stoller forecasted growth.
- ▶ Maximize use of Timberland facility.
- ▶ SUMMA programs at Meadow Park, Stoller, Timberland
- ▶ Compromise JW walkability in exchange for healthy feeder patterns and keeping friendships through high school.

I still think this is the wrong way to calculate these numbers. This new document attached explains why- please include it with the comments. Basically, growing areas will send more students to options and Summa. Shrinking areas will send fewer students to options and Summa. Even if the overall totals remain the same for the district, you can expect the Summa and options numbers by elementary zone to move up or down proportionally.

Think about it this way- let's say Elementary Area A had 50 kids for the past 3 years, and sent 5 of them to options programs on average (10%). In five years, this area will grow to 500 resident kids. In five years, Elementary Area A will not send only 5/500 of them to Summa- they will send around 50, or 10%.

Elementary Area B may have had around 500 students for the past three years. They sent 50 of them on average, or 10%, to options programs each year. Over the next five years, they will shrink to only 50 students total. In five years, Elementary Area B will not send all 50 of these kids to options programs. They will likely send around 10%, or 5 students total.

Elementary Area A and Elementary Area B will send 55 students to options and Summa in total, both now and in five years. If the programs are capped, we aren't exceeding the cap. However, the difference is in how many students come from each elementary school. If Elementary Area A is zoned to one middle school, and Elementary Area B is zoned to another, you can see how this would have an impact on middle school numbers.

Flat Summa and Options Projections in 2025 Are Causing Overcounts and Undercounts of Net Resident Students



In the data provided in the 2/25 agenda packet, the district is projecting resident numbers by elementary school, which may go up or down due to changes in populations for that particular area.

However, regardless of total resident numbers and the upwards or downward trends, the number of Summa and Options students in each elementary area are flat.

For example, let's look at Beaver Acres just to illustrate:

In 2021, Beaver Acres will have **364** resident students.
69 will attend options programs.
3 will attend Summa.

In 2025, Beaver Acres will have **only 283** resident students.
69 will attend options programs.
3 will attend Summa.

So, despite shrinking overall by 81 students (-22.3%), the count of those attending options and Summa from Beaver Acres will be exactly the same.

One would expect to see the numbers of Beaver Acres students choosing options and Summa also shrink by 22.3%.

This flat projection is seen across all elementary schools in BSD in the data provided in the 2/25 packet.

- If this number is correct and continues to be accurate in future years, then in 2025, we can assume there will be around 194 Students in Summa from Jacob Wismer
- This will bring the Jacob Wismer net attending in boundary school in 2025 to potentially only 154 students

We have noted in meeting materials that the SUMMA numbers are based on a 3-year average enrollment. Because the actual enrollment will be based on the number of students who pass the entrance exam and choose to enroll in the program, we cannot accurately predict growth or decline in the program. We stated that for this project, we would assume the 3-year average (625 students) as the number of SUMMA students for the projections. The locations of where projected Summa students are based is also determined by an average from past years.

The average from past years is a great starting point, but this method does not work. We are talking about the next five years, where we will see changes in overall student populations that will be different from the last three years.

**2021 numbers are not the same as 2025 numbers,
and neither will match an average from 2017-2020.**

You may still end up with around 625 students total for Summa district-wide.

You may still end up with around 1562 students attending options programs district-wide.

However, growing areas (like Sato) will provide more of those 1562 students, and shrinking areas (like Beaver Acres) will provide fewer of those 1562 students.



Why does it matter?

If we are hung up on a small difference of 5-10% in capacity for a building (only 50-100 students), we should make sure we are accounting for all students correctly.

Don't create splits based on unclear data for 2025!
