I am writing in support the most recent working map for the upcoming meeting. This map does what a few committee members mentioned during previous meetings and what many parents have asked for, it makes simple, straightforward changes and minimizes disruptive elementary school splits. I support the map for these reasons:DO NOT SPLIT ELEMENTARY SCHOOLS - Springville, Sato, Findley, Rock Creek and Oak Hills have all been shown split in various maps proposed by the committee or BSD. Studies have consistently shown that minimizing transitions results in better academic performance and emotional health for children. I support this map as it minimizes ES splits.KEEP COMMUNITIES TOGETHER - Sato and Springville students and families make up the North Bethany community. Splitting some of Springville to go to Five Oaks disrupts this community as we currently share the same parks, trails, and local activities. Stoller is the only neighborhood area middle school for North Bethany students. Rock Creek is naturally tied to Springville and Bethany; it should not be removed from both. If any portion of Rock Creek is removed from Springville, it should be placed with Bethany. West Oak Hills is part of the Bethany Elementary community and should remain so. They are a time of social awkwardness, and a time where children are discovering themselves. This is one of the main reasons communities are so passionate about voicing their opinions through this boundary adjustment process. However, it seems that many have gone beyond just voicing their opinions and have taken extreme measures to fight for what they believe is best for their kids, and not looking at what is best for our entire school district. This behavior has only divided communities, created hostility and has put every committee member in an uncomfortable and awkward position. The fact remains, that Stoller in particular is overcrowded beyond any acceptable measures. I've lived in 2 different provinces in Canada and 3 different states, and I have never seen a school with 14 portables, unless the school was under mass renovation and it was a temporary fix. Stoller has had portables for years now. The problem has reached a point where it MUST be fixed and NOW is the time to fix it. But please, let's fix it with a long term solution and not a band-aid that will have us right back in this same situation in 2-3 years. We owe it to our students, our staff, our administrators and children. Here are some VITAL UNBIASED data points. Despite some communities trying to refute these points, they CANNOT be refuted. 1. SPV & Sato ARE the 2 largest communities in the BSD and ARE continuing to grow. There are no drone images of the area that can argue this fact. They are also the 2 communities with the most NEW homes, whether the land is still being built or not. This is a problem today and for the next few years. Your committee has already agreed that a split to SPV is likely necessary. Although the idea of a split is not ideal, the number of students just does not work and the problem of overcrowding will NEVER be solved if we continue to have all of Sato (growing), SPV (growing), JW (flat) and Findley (declining) feed into Stoller. With or without Summa, it DOES NOT and WILL NOT work. 2. Transportation costs money. Bus drivers need to be paid and buses need to be maintained. Adding more buses to the roads simply because some neighborhoods have blatantly stated they - don't want their kids to be sent to a horrendous school like FO - is just outrageous, inappropriate and condescending. The district did due diligence to carry out test runs to verify the length of time it would take to commute students to this further away school, and the results clearly demonstrated that it is only 5 minutes longer than the commute they endure to Stoller today. That commute is on the same bus and with the same bus driver. Therefore, the incremental cost is way less than adding more buses to move walkable students away from the school they can walk to. This leads me to point 3... 3. Walkability MUST be considered. We cannot keep spending money our district doesn't have. Let's keep those funds in the classroom where they WILL benefit ALL students in every school across the district. Please keep walkable Findley at Stoller with their Sunset bound JW peers. 4. Summa is NOT an option school. To those suggesting that it can't be possible to have so many FE and JW students legitimately qualify for the program, well, IT IS. No matter how they qualified, they went through the process and were invited into the program. As we heard, it was developed to exist in neighborhood schools. So let's keep it in those neighborhood schools where they belong. It helps improve split feeder patterns to HS and keeps walkable students off expensive buses. 5. Feeder Patterns - please look at all possible ways to keep any splits even, or to keep walkability in place. Stoller feeds to Westview and Sunset. By moving all of Findley out of Stoller, it leaves JW students heading to Sunset from Stoller with only 17 percent of their graduating class. If Summa is moved out, that number goes down to SINGLE DIGITS. I remain confident in this process. However, I urge you to please consider the above points that are VITAL to meeting the objectives. The Cooper Mountain community prefers the current existing boundary which aligns the Cooper Mountain to Highland Park feed into Mountainside High school. The updated map moving all of Cooper Mountain to Mountain View to reduce the percentage of free lunch is purely political to make Beaverton School District feel balanced. This a typical smoke screen of the data. By increasing the numbers it appears free lunch percentages would go down for Mountain View. The reality is the same students will still need free lunch. This change does not help those students. In addition, two more bus routes would need to be added, raising transportation another \$50,000. A large percentage of Findley students can walk or bike to Stoller, but 100% of them would require bussing to Timberland. ### Additional Potential Amendments

Pursuant to the committee's direction at the end of the February 25<sup>th</sup> meeting, staff have reviewed the following potential map amendments:

1. Five Oaks MS #1

The Committee requested to see additional data on the potential for the all of Rock Creek ES and a portion of Springville ES (south of Brugger Road) feeding to Five Oaks MS. The following datapoints begins with the March 12 Working map, in which Five Oaks boundary is the same as it is today.

With changes:

*Building Utilization (2021):*

Five Oaks MS: 1,185 net resident students (113% of capacity)

Meadow Park MS: 628 net resident students (73% of capacity)

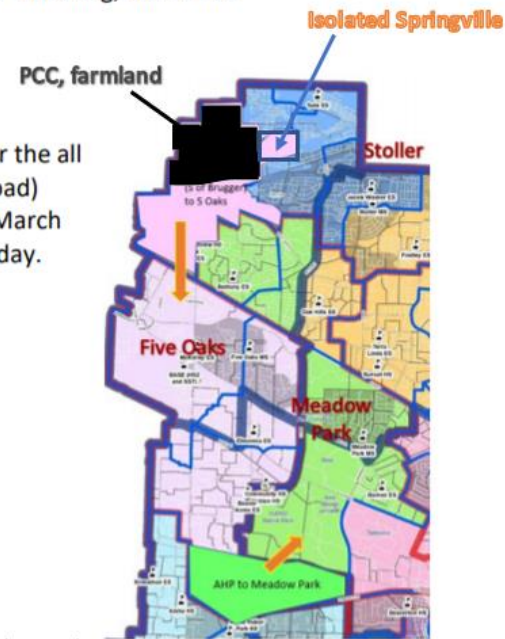
*Building Utilization (2025):*

Five Oaks MS: 987 net resident students (94% of capacity)

Meadow Park MS: 510 net resident students (60% of capacity)

*Transportation:*

375 students would be bussed to Five Oaks. 102 students would be bussed from the Springville area and 273 students would be bussed from the Rock Creek area. 141 Aloha Huber Park students would be bussed to Meadow Park rather than Five Oaks. This would consist of 9 bus routes that already exist.

- 1) Findley's neighborhood school is Stoller. All of Findley kids are within ~1.5 miles of Stoller, in spite of that Findley is being bussed to Timberland. For the greater good of the community and so that Findley remains united we are accepting that. Having said that, Cedar Mill is not Findley's neighborhood area. Kids will not see familiar faces, but yes they will have the opportunity to make new friends that is the only positive side of this with too many unknowns and uncertainties.
- 2) Since Summa is not confirmed and given that there is already a Summa at Stoller and Meadow park, in the event Timberland does not get Summa, Findley kids will most likely have to take two buses and go to Meadow Park. This does not look like a logical solution in terms of budget, emotional health of the kids and transportation logistics. But given BSD says Teaching and Learning will decide, then what if Teaching and Learning comes up and says that Summa at Timberland is not possible. So Findley kids will have to be again transferred to a new school? What is BSD's plan towards this? Understand that Teaching and Learning need to take the final call regarding Summa. Why is BSD not engaging Teaching and Learning at this moment? Why will that be done after the boundaries have been finalized? Per Mr. Sparks, if the main goal of this project is to reduce overpopulation at Stoller, how can that be achieved without addressing a huge Summa population (~44% from Findley and ~47% from Jacob Wisemer) at Stoller. Is there any rules/bylaws that is preventing BSD to engage with Teaching and Learning at this moment. I appreciate an official answer from BSD about this.

Mr. Sparks mentioned in the Findley PTO meeting that we should not be protesting like some schools are doing. Findley is following all the rules and working professionally with BSD as much as we can, but sad to say looks like Findley's less activism and protest is making Findley the soft target for many people and hence Findley is getting the worst possible deal from this entire project. Please refer to the above table to understand what Findley is getting and what many other schools are getting. How can some schools have it all and for some it is all sacrifice for being one of the best schools in the neighborhood. In my February 13<sup>th</sup> Testimonial I had requested for an optimal solution. Sad to say, many schools are getting the best solution and Findley is getting the worst, nowhere close to

optimal solution. My request to BSD is to sincerely work with all required stake holders and sincerely work towards an optimal solution for Findley. Below are the two optimal solutions:

- 1) Either entire Findley stays at Stoller. If there is no space for Summa after that then entire North Summa goes to Timberland. General population should be given first preference then Summa this is per BSD.

OR

- 2) Entire Findley along with North Summa goes to Timberland

BSD can only have a win-win solution if all schools win some and loses some. After contributing so much to the community, Findley kids cannot lose everything. The primary stake holder of this project is '**KIDS**', and I request BSD to work optimally for Findley Kids. Unless Findley gets the assurance of entire Summa, BSD will be doing a major injustice and discrimination against Findley. We hope BSD will take every effort to prevent that.

I am Findley mom of current 5th grader, who will go to Summa next year.  
I first want to thank you for all your hard work throughout this boundary adjustment process.

I am following this process closely since November and attending all the meetings. It is very frustrating to see the objectives are not clear from the beginning, especially about the Summa program. It is stated towards the end of the process that Summa program is "Teaching and learning" department's choice. Why is this not stated earlier?

Data for Springville is updated before the last public meeting. The map on Feb 25th meeting is back for March 12th meeting with updated data. This is very frustrating and we lost hope and trust on BSD for doing this.

Currently, in Stoller, the summa program is very strong, as they have a minimum of 270 summa kids anytime. With Findley leaving Stoller, neither Stoller nor Timberland will have this 270 student count to have full summa experience including 3 tier math programs. We strongly request committee and BSD to ensure Stoller and Timberland Summa are merged to one location. This should be in Timberland, as there is no room in Stoller for this. With East OakHills moved to Timberland, Timberland will be overcrowded, to have summa for Stoller and Timberland. It is the responsibility of the committee and BSD to ensure there is room in Timberland for full summa.

Please consider moving East OakHills to Stoller. This will resolve isolation issues for both East Oakhills and for Jacob Wismer.

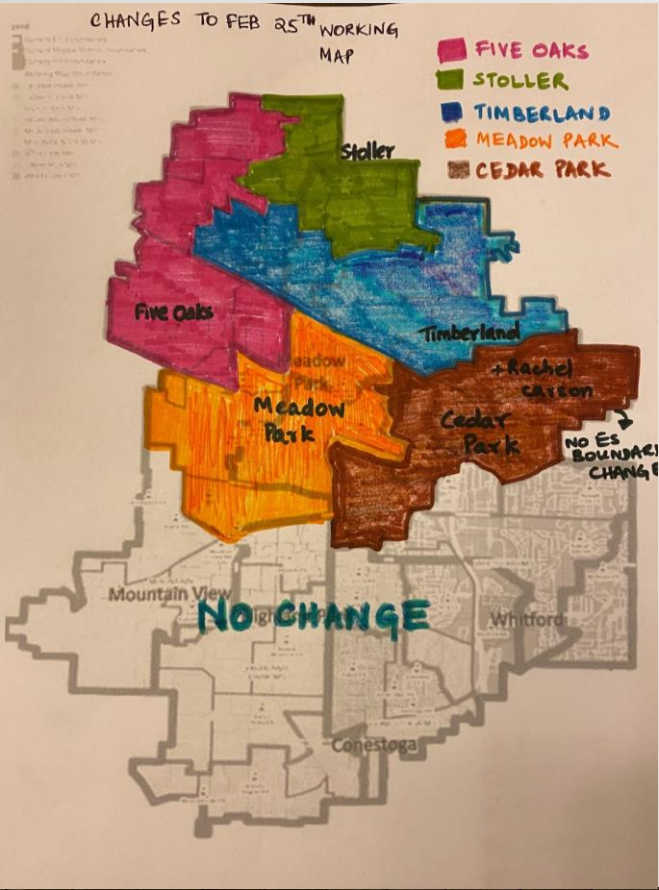

The meeting packet says that Summa discussion and decision is outside the scope of BSD. BSD's main goal is to make sure Stoller overpopulation is reduced and Timberland is not under capacity. When there are ~44% Summa kids from Findley, how will BSD optimally work with the overpopulation issue of Stoller without addressing where Summa kids will be. Per my understanding, 44% is a big number. 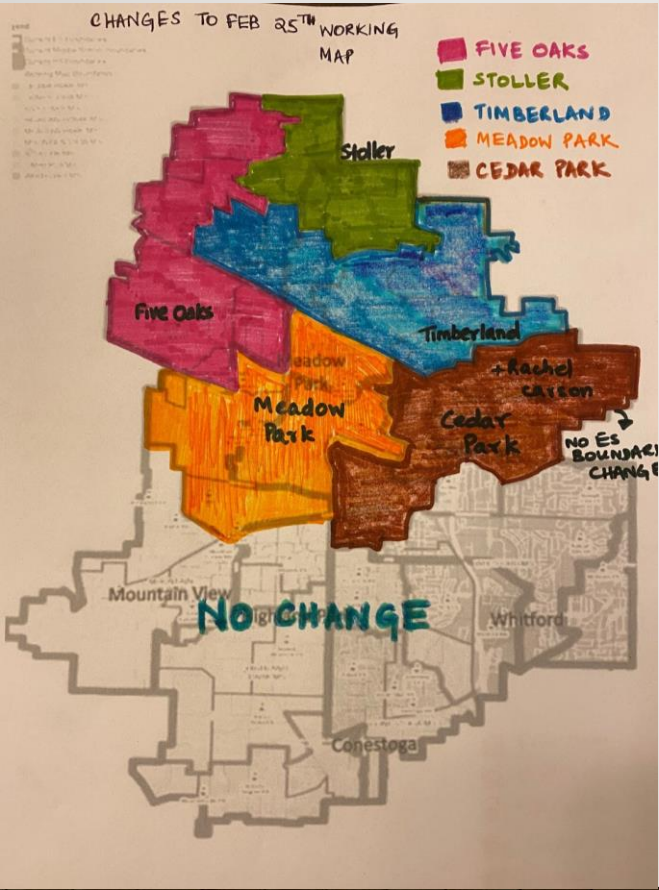

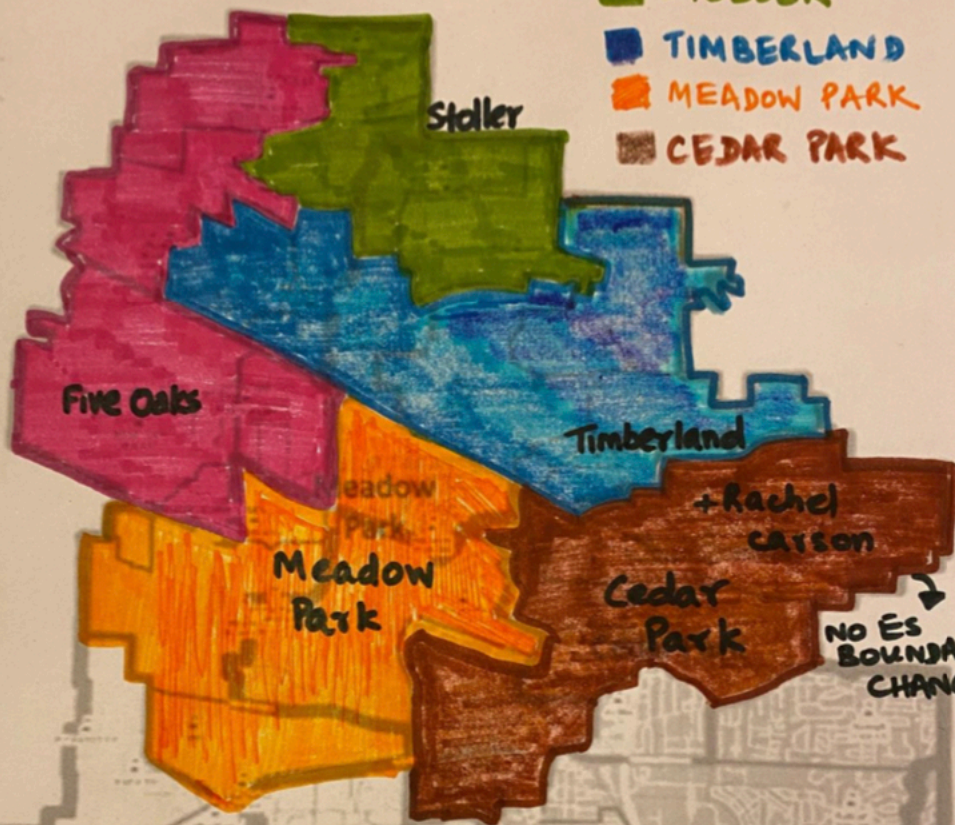
