I agree that any and all materials created by Elmwood, its governors, employees and agents that incorporate, in whole or in part, my child’s name and/or photograph/likeness (the “materials”) shall remain the sole and exclusive property of Elmwood and Elmwood shall retain all intellectual property rights, including without limitation, copyright that exists in the materials. I understand that no additional rights or consents are necessary to grant the rights to Elmwood as provided herein. I understand that there is no obligation by Elmwood to use the rights or any materials as provided herein or to produce or release any advertising. I further understand that, subject to legal or contractual exceptions, I may withdraw my consent for secondary purposes (for example, alumnae relations, fundraising or promotion) by contacting the Privacy Officer at 613 749-6761 ext. 236.

## **G – General Waiver**

By my signature below, I give permission for my child to participate in all of the activities contemplated by the program herein including, without limitation, sports, athletic programs, co-curricular activities, outdoor education, excursions and field trips. I acknowledge that such participation involves risks and hazards incidental thereto, all of which are expressly assumed and I hereby waive, release, absolve and agree to indemnify and save harmless Elmwood, its governors, employees and agents of and from any and all actions, causes of actions, complaints, demands and claims whatsoever in existence prior to on or after the date hereof whether in law or in equity, in respect of death, injury, loss or damage to person or property howsoever caused, except to the extent that the same are caused directly by the gross negligence of the aforementioned releases.

## **H – Medical Release**

In the event of illness or an accident while participating in any of the activities contemplated by the program herein, I understand it may be necessary to take my child to a doctor or to a medical facility for treatment. Should this happen to my child, I understand every attempt will be made to contact me at the telephone numbers I have provided. In an emergency or life-threatening situation, I understand that hospitals or other healthcare providers may be required to provide treatment without my consent. Should an Elmwood representative be unable to obtain my consent for treatment for any medical condition or accident, by my signature below, I authorize a representative of Elmwood to act on my behalf by contacting our family physician and/or by arranging for transportation, by emergency vehicle if necessary, to a hospital or other medical facility. Any doctor, transfer service, or medical facility may rely on this release to administer appropriate treatment or surgery necessary in the opinion of an attending physician.

## **I – Behavioural Expectations**

Elmwood School is committed to offering a safe, happy and inclusive environment for all camp participants. An emphasis is placed on kind, respectful interactions at all times. If a camp participant's behaviour consistently fails to meet these expectations, Elmwood School reserves the right to ask that participant to withdraw from camp.
