Complete the SCLA Scrip Agreement and send it to the Scrip coordinator in the front office. The Scrip coordinator will then provide you with the SCLA enrollment code needed to create an online ShopWithScrip.com account.

## Set up your account...

Visit ShopWithScrip.com, click on "Get Started," then "Join a Scrip Program," and enter the SCLA enrollment code. Finish setting up your account and gain access to rebates from regular cards, e-cards, and reloadable cards from hundreds of popular vendors. ### Order & Pay Online

Login to ShopWithScrip.com, load your cart, and pay using a credit card (2.6% fee), PrestoPay (.15 cents per order), or by cash or check in the office (orders will not be fulfilled until payment is received).

Visit MyScripWallet.com using your phone and save the page to your home screen. You now have an easy-to-use app plus the ability to use Scrip instant e-cards.

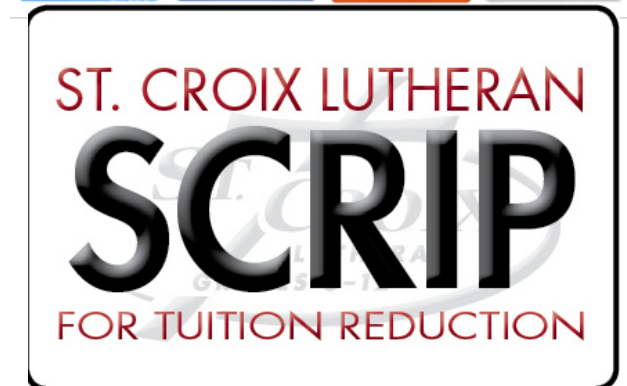
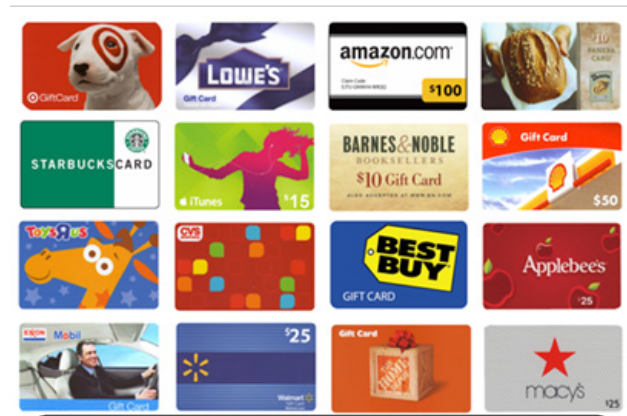

The Great Lakes Scrip Center acts on behalf of schools, churches, and nonprofit organizations to purchase large amounts of Scrip from over 700 participating retailers at a substantial discount.

SCLA buys the Scrip from Great Lakes Scrip Center at a discount, and resells the certificates to families like yours for full face value. Most of **the discount, from 2% to 15% or more, is tuition credit for you.**

## JOIN the 150+ families who use Scrip!

This is the exciting news: **75% of the rebate on any retailer's Scrip can be designated for tuition credits** for your children or can be designated to another family. The remaining 25% is used to cover administrative fees of running the program.

A Scrip tuition credit account may be opened for families with children as young as newborns. Grandparents, other family members, co-workers, or neighbors can also purchase Scrip that can accrue towards YOUR Scrip family account. **Just complete an agreement form and register online to open your Scrip tuition credit account.**

## SEE HOW the SAVINGS add up!

### You spend per month:

\$500 at Cub Foods x 4%	= \$20
\$400 at Gas Station x 9%	= \$40
\$100 at Restaurants x 10%	= \$10

### Plus additional one month:

\$150 at Kohls x 4%	= \$6
\$200 at Home Depot x 4%	= \$8
\$40 at Dominos Pizza x 8%	= \$3.20
\$200 in Gift Certificates x 5%	= \$10
