- Lead Teacher
  - Bachelor Degree in Early Childhood or Child Development
- Associate Teacher
  - Associate Degree in Child Development, Early Childhood or Child Development Associate Certificate (CDA)

### ❖ **Recruitment & Enrollment (Eligibility)**

- Students are selected based on income
- Risk factors in their life placing them at risk for possible school failure

### ❖ **Classroom Environment**

- License: Without violations
- Great Start to Quality Rating: Minimum of  (3) star rating

### ❖ **Classroom Routine**

- Schedule: School day
  - 7 hours minimum daily
  - 4 days a week
  - 30 weeks a year
  - 120 days a year
- Family style meals

### ❖ **Curriculum**

- Developmentally appropriate anti-bias activities
- Research based MDE approved curriculum

### ❖ **Child Assessment**

- Online: COR (HighScope)

## What is GSRP?

GSRP is Michigan's state funded Pre-K program. Serves 4 year old children who meet income and other eligibility criteria. All classrooms use a research-based curriculum and comprehensive child assessment tool. Classrooms have credentialed lead and associate teachers. Parents are involved in the program in multiple ways.

### **Can I be a GSRP provider?**

GSRP is provided in licensed childcare centers, with a regular license. Eligible centers need a minimum three star rating in Great Start to Quality (GSQ) system.

***Would I have to meet all program requirements to be chosen as a GSRP provider?*** Yes, you will be expected to hire qualified staff, have staff trained in the curriculum and assessment tool, etc. You will have to operate in compliance with childcare licensing rules and GSRP statute, policies and procedures.

### **What do I have to do to apply?**

- A Wayne RESA staff person will complete an on-site visit, often unannounced. Please let local staff know to provide access.
- License will be reviewed (DHHS Website) to document good standing.
- Visit link here for MDE Implementation Manual to review requirements.
- Wayne RESA assigns an Early Childhood Consultant (ECC) to support your agency's start up, help ensure full enrollment, verify staff qualifications, and support curriculum implementation.
