ENROLLMENT CONTRACT – NEW STUDENT

The parent or guardian must sign and return to the Admissions Office accompanied by a \$700 non-refundable deposit and registration fee.

In consideration of the acceptance of this Enrollment Contract by Malden Catholic High School, and Malden Catholic High School reserving a place in the graduating Class of 2024 as indicated, the undersigned agrees to pay in full the required annual charges and fees as determined by the Board of Trustees.

I/We agree that this enrollment contract remains in full effect for each year of attendance through Year of Graduation. I/we also, agree that my obligation to pay the charges for Tuition and Fees for each full academic year is unconditional should the student withdraw for any reason after August 1st of each Academic Year. No portion of such charges so paid or outstanding shall be refunded or cancelled notwithstanding the subsequent absence, withdrawal or dismissal of the student from Malden Catholic. This Contract terminates upon the graduation of the student in good financial standing or a formal withdrawal of the Student prior to the August 1st deadline.

My child/student is enrolled in a health insurance plan in the event of illness or injury. In addition, as parents/guardians, I/we recognize that there are inherent risks to student participation in the athletic activities at the School. I expressly agree that the School is not responsible for athletic injuries. I understand that the school does not provide health insurance coverage of any kind for students.

I understand that in signing this Enrollment Contract, I am agreeing to accept the rules and regulations of the school as stated in the Student - Parent Handbook and the Tuition and Fees as adopted by the Board of Trustees and the Headmaster and of which I acknowledge receipt.

I understand and agree that Malden Catholic High School reserves the right to withhold my child's grades, diploma and transcript and suspend my child from class until all tuition and other fees are paid. It is agreed that any costs associated with Malden Catholic's collection of delinquent/disputed tuition and other fees shall be my responsibility. It is further agreed that enrollment, as specified within this Enrollment Contract, may be cancelled in writing and sent to the Director of Finance and Business Operations, without damages (except forfeiture of the non-refundable amounts) **prior to August 1**. If enrollment is cancelled on or after **August 1**, parents or guardians financially responsible for the student are obligated to pay the full tuition and fee charges, as liquidated damages.
