Temple City High School:
Back Field

- Moved around all the storage containers
- Build retaining wall behind them because it was a sloped hill
- Opened up the whole track area and it was really a big undertaking, very unorganized
- Moved all the containers around there, all labeled now, has a master sheet in the offices
- Did "TC and RAMS" logo's in concrete so you can really see from the bleachers

Fencing

- On the tennis court, had to do emergency repair on the west side because it was getting ready to fall, few broken main supports, had to secure before getting it replaced
- Put new green vinyl fencing in the front
- Along Camino Real
- Center field in the Baseball Field

Baseball Bleachers

- Little dated and getting code violations from some inspections,

purchased for visitor and home side new aluminum bleachers, up to
code now and finished

Chiller

- Took out circulation pump
- Had to crane in 2 new pumps and motors, completed over summer
- Getting ready to be shipped out for rebuild, we'll have a backup if we ever needed it
- Mr. Tauer asked what the Chiller is. Mr. Alfano replied that the Chiller is the AC system for the 300 ,400 500 wings at the high school, instead of conventional air conditioner, it runs chilled water in through air handler

Emperor Elementary School:

Kindergarten

- Gave a little color, asked for by Dr. Chang over the summer
- Cleaned up, did it in-house, quick and easy

Longden, Oak & TCHS Schools:

Keying

- Completed Longden
- Had 400, 500 wings done at the High School
- Oak will be commencing in January after the 1st of the year. Their 2-story building will be the first one done and the gates. That one and the high school will still be continued on through next year

Oak Intermediate School:

Main Field

- Killed off all the grass, lot of potholes, very uneven, everything's leveled out
- Put new irrigation system in, all new valves, pipes, sprinkler heads, clock, just about finished
- Spraying for the hydro seed on Monday morning, get to watch it grow
- It is a big field back there, took a lot of work, irrigation done in-house, contracted out the killing off the grass and leveling off the field, same company to do the hydro seed
- Member Goold asked what the quick coupler that is added to the field. Mr. Alfano said that Instead of having a hose bib sticking out of the ground, coupler in, it goes down, quarter turns and hose bib comes out of that so you can run a hose out there and it won't be sticking out, it is a water source, not part of sprinklers

Gym

- Done earlier In the year
- Put up pads on the north and south side of the gym
- Took all paneling down, put up these pads
- Had to redo the floor drapes where the ventilation system was
- Cleaned up, other walls still have paneling, to continue and finish it off

- Member Knollenberg asked if this is the area that has the fans. Mr. Alfano replied that the high school gym has the fans also. Member Knollenberg said that the ones at Oak make so much noise and asked if that has been resolved. Mr. Alfano replied that he has not been advised of any noise from them. It makes some noise if you turn them up full blast but it makes variable speed drives you can keep them low, designed to run at lower speed and still get the airflow.

Carpet/Flooring

- Redid a lot of carpeting and some vinyl flooring on the 400, 500 wings
- Had to do some abatement on some asbestos tile that was underneath, was unforeseen during the beginning of the project
- Came out really nice

Facilities & Purchasing:

Windows and Carpet

- Replaced windows were falling apart
- Lot of termite and dry rock damage in them
- Did some paint and carpet in the Purchasing office

TCHS & Longden:

Trees

- Met with city and said that if irrigation on Camino Real and Longden were added , they would provide the trees and the upkeep, they provided 30 trees
- They are Golden Trumpets, yellow flower on them, will blend in with the high school
- Crape Myrtles down along Longden

TCHS:

Carpet

- At the 500 wing, did the carpet for the 3 rooms that needed it
- Quick and easy

Member Marston asked about the next 6 months or so. Mr. Alfano said that he discovered a lot of things in snack bar that they are going to be doing at the football stadium, some work inside the snack bar in the football stadium. Will be keeping it open for football games but will start on that. Will have some other carpet going in January, some more locks and keys at Oak, getting prices on some AC units at the 700 wing (over 20 years old), discussion on some other bigger projects with Marianne.

- Has concerns with the Change Orders. When you are addressing the change orders and you are talking about them being fully vetted, some of the items are not in the initial bid. Concern is that when you are looking at these change orders and seeing things that require ADA compliance, that should have been caught when you were drafting your plans whether it was this board or the previous board or three years ago. You should have caught some of these things before TELACU even got this to the bid because those were standard issues with compliance. Another concern is that this is a lot of money on some of these change orders. Considering this board's history and looking back at previous change orders especially to the High School, I am little bit concerned because all of a sudden now this is ok because you are informed but you should have been informed before it got to this point.

Jason Miller, TELACU

- Had unforeseen things we had to address and petitions to take care off, we are about 65-70% through that project. This is our first change order.
- Member Bell asked for a brief summary of the change order to help the public such as Edison determined that we were not in compliance. He asked if they come out (Edison) to look at all these stuff before during the planning phase. Mr. Miller said the plans were done 3-4+ years ago and went to the state for approval. Had to engage SoCal Edison for the new electrical volt and new meters going in. After their review of what was done there and our plans, they decided that our service that was required, our electrical volt that was in our design designed by the engineer some years ago wasn't gonna be adequate for the service that we need. Had to go back to our engineer and tell them what Edison was looking for and redesign the volt. Why it was changed? Edison does what Edison wants. According to our engineer who has been involved in the project for a while that wasn't their initial indication.
- Big ticket items: There is a typo on the square footage - 13, 500 square feet. Initial design mainly based on as built which are basically drawings leftover from previous projects. If those as built are incorrect, sometimes the new drawings and plans are going to be incorrect because of that. This is something that we found specifically in that concrete area. If you look at it on paper it all

looks good but when you go out and start putting a smart level on things, you'll find out that it was not ADA compliant. For hazardous materials, we took out the ceiling in the locker room and it had lots of asbestos installation that we had no idea that was there. Member Bell asked about the modernization – pool and lockers. He asked if we are in between for the modernization of the lockers that are next to the pool. Locker rooms are being utilized now but not 100%, still construction happening after hours in those areas. Staff and students are utilizing it. There is additional work that needs to take place in those areas.

Jason Miller, TELACU

- Anticipating of turnover for the last phase for kindergarten at the end of October. Will get the staff and students moved over to the new rooms.
- This change order encompasses a lot of the can of worms that we uncovered when we got into kindergarten and also some of the elective upgrades that we decided to do while we had the can of worms opened. Came across things that were not documented through the state that we had to take out. Came across water damage, termite, mold damage more than anticipated, decided to insulate the walls which were not insulated and not part of the initial plans, mechanical upgrades the HVAC system and new case work and finishes.
- Member Marston asked a suggestion on how we can have gone differently to prepare a bid for this project
- Mr. Miller was not involved in the design development for this project but it's my understanding that the parties that were involved decided that this phase of project would just get a facelift, just a couple of finishes and they would move on. In the course of our construction, we opened walls and found things that we knew we were gonna have to fix and decided in the course of fixing those things, we would basically give those rooms what the rest of the site got. Member Marston asked if it up ended being cheaper to go ahead and change those orders and fix these issues, the water damage, termites, improper building that was done than just giving them a facelift. Mr. Miller said that if they had just done the facelift and ignored the things that we discovered, we would have big problems in the future.

- On the Consent Agenda on the Unapproved Minutes for the Board meeting on September 12, after you reconvened to open session, you don't disclose whether you took action or no action which could be a Brown Act violation. Need to correct to be compliant with the law so minutes will accurately reflect to determine whether you took a legal or non-legal action during that time.
- Addressed Member Knollenberg's comments on page 4 of the minutes regarding lack of communication with parents to help kids get through school such as if parents need to take them to museums and historical sites. Last time I checked, Temple City is still in the top 40 school districts in the state. I don't think our parents are having a communication problem but I think this is a very inappropriate statement for a publicly elected official and would caution you that perhaps you need some ethics training and EEO training to be a better public servant.
- If you withhold two regular meetings, you wouldn't have all these purchase orders to pay which is somewhat misleading and cram it all in. Item 151 for Legal services for \$ 48,318.46 and Item 152 for \$98,779.84. Fiscal year just started July 1st and that's a lot of money in legal fees. Are these bills intentionally held during all of the chaos of last fiscal year to get to be paid til now which would be somewhat a financial irregularity if that was the case.
- Need to look at amending EEO and complaint policies on staff. There is a problem and lack of communication, not sure if staff up to date on California and Federal law on how to handle complaints.

Member Marston:

- Recalled reporting out that there was no action taken in closed session. Need to have it reflected on the minutes. Will pull the Special Meeting minutes so that can be amended and be approved for the next meeting.
- Member Marston asked Ms. Sarraill if she can breakdown the legal fees that were mentioned.

Marianne Sarrail:

- Ms. Sarrail stated that the two checks that were referenced total of \$147,098.30 primarily made up of three main areas. First one is \$65,293.08 for personnel matters related to investigation and audit. Second main area is General counsel \$18,657.19 related general operations of the district. Third is \$63,148.03 primarily related to responses to many requests for public information and a Cure and Correct on Brown Act.
