- TCHS Phase 1A: punch list items are being addressed, teachers have begun room setup, the bulk of furniture has been delivered, exterior concrete flatwork is being cleaned and sealed.
- TCHS Phase 1B: the plans have been approved by DSA, TELACU is preparing a bid schedule for the project, the Interim Housing removal project has begun with the de-energizing of the electrical panel and removal of the asphalt paving around the buildings
- TCHS Building 500: abatement, demolition, framing and drywall is complete, tackboard panels are being installed, lighting is being revised, the project consists of the interior demolition of 3 classrooms replaced with the construction of 2 classrooms
- Longden Modernization Project: demolition and abatement is complete in the first, second and third phases, drywall and insulation complete, plumbing and electrical rough in is complete, cabinets have been installed, interior painting is complete, HVAC ductwork is in progress
- Cloverly Modernization Phase 2: the architect has begun the Design Development Phase of the project and TELACU continues to monitor the progress and review cost estimates as they are available
- La Rosa Modernization Phase 2: the architect has begun the Design Development Phase of the project and TELACU continues to monitor the progress and review cost estimates as they are available
- Prop 39: there is now an additional estimated \$350,000 available to the District due to new California Energy Commission Guidelines, TELACU has solicited an RFP for a consultant to amend the previously approved Energy Expenditure Report, a total of 4 responses received
- Oak Ave: District and TELACU are reviewing options for the Oak Avenue Modernization/New Classroom Building Project, the general

scope will be the demolition of Buildings 400 and 500, construction of a prefabricated 2-story classroom building, and the modernization of the gym, including the adjacent classrooms, the gym locker rooms project is complete

participation in federal programs including: Title I Part A, Basic Grant (Low Income/low achieving students), Title II, Part A (Teacher and Principal Training and Recruiting), and Title III, Part A (Limited English Proficient [LEP] and Immigrant Students). Federal guidelines also allow local non-profit private schools to participate with the public school district in federal programs. Those participating private schools are identified in this spring data reporting.

As a requirement of the Elementary and Secondary Education Act (ESEA), the district continues to make the necessary adjustments and modifications to meet continuing legislative provisions of the aforementioned programs.

These Federal categorical programs are currently funded through the Consolidated Application:

# Title I Part A: Helping Disadvantaged Children

A Federal program to ensure that all children have a fair, equal, and significant opportunity to obtain a high-quality education and reach, at a minimum, proficiency on challenging state academic achievement standards and state academic assessments.

### Title II Part A: Teacher Quality

A Federal program that increases student academic achievement through strategies such as improving teacher and principal quality and increasing the number of highly qualified teachers in the classroom and highly qualified principals and assistant principals in schools.

### Title III: Program for Immigrant Students

A Federal program to provide supplementary programs and services to eligible immigrant students. The purpose of the subgrants is to assist immigrant students to acquire English and achieve grade-level and graduation standards.

### Title III: Program for LEP Students

A Federal program to provide supplementary programs and services to limited English proficient (LEP) students, known as English learners (ELs). The purpose of the subgrants is to assist EL students to acquire English and achieve grade level and graduation standards.

Each school receiving Federal Funds through the consolidated application is required to have a comprehensive school plan known as the Single Plan for Student Achievement (SPSA) describing strategies and activities to improve student achievement and meet district adopted standards. Each school's School Site Council (SSC) is required to provide input, assist in the plan/budget development and recommend to the Board annually for approval the planned program activities and budgets as part of the Single School Plan for Student Achievement. The Assistant Superintendent of

Educational Services reviews program regulations and guidelines with all administration, site staff, and School Site Councils to insure appropriate planning, implementation and evaluation, and to maintain compliance for each program. All site plans are reviewed for compliance along with goals and activities to improve student achievement and parent involvement before being forwarded to the Board for approval.

An approved Consolidated Application will allow the district to be eligible for approximately \$1,115,684 in Federal funds. Exact funding entitlements for Title I, II, and III will not be received until February 2018.

On motion of Member Marston, seconded by Member Bell, and on a 5-0 vote (Aye: Bell, Goold, Knollenberg, Marston, Pomeroy), the Board approved the Agreement with Century Paving for the Emperor Elementary School Paving project.

The conditions of the asphalt paving at all sites were evaluated and prioritized based on prior repairs, current uses and what would be included in Bond projects. It was determined that there was a need at Emperor to remove and replace all of the asphalt paving throughout the campus. On July 18, 2017, informal bids were received and opened at 1:00 PM. Being that most asphalt work is done during the summer and this project was a CUPCCAA (California Uniform Public Construction Cost Accounting Act), there was not a lot of interest due to the fact that this project needs to be completed in August.

A total of 1 bid was received; Century Paving \$ 115,000.00. The District and TELACU Construction Management have verified the bid document submission, verified licensing, workers compensation, bonding capacity, conducted a Post- Bid Interview, and is recommending the award of the contract to Century Paving as the lowest responsible bidder.

Bid Amount: \$115,000.00 (Deferred Maintenance Funds) Budget for asphalt replacement at Emperor for the 17/18 Fiscal Year: \$150,000.00

(balance of \$35,000.00 to remain in the Deferred Maintenance budget)
