ROSEBURG EXTRA/CO-CURRICULAR CODE OF CONDUCT

1. Purpose of the Code of Conduct

Our extra-curricular programs provide important opportunities for students to pursue interests and develop worthwhile skills beyond the classroom. Extracurricular participations promote the development of a wide range of intellectual, physical, and social skills within a team or group contest. *Participation in extracurricular activities is a privilege granted to students who have demonstrated a commitment to meeting the academic and behavioral standards of the school district. This privilege is offered to students willing to comply with school rules and the rules set forth in this code of conduct.* Students participating in extracurricular activities are expected to exemplify high standards of moral conduct and to serve as role models and representatives of our school district and community.

2. Enforcement of the Code of Conduct

The rules contained within the code of conduct apply to students in grades 6-12. The rules contained in this code of conduct are in effect for the entire time a student is participating in an activity within the current school year. During the time a student is participating in an extra-curricular activity, the code of conduct is in effect 24 hours a day, 7 days a week. The rules within the code of conduct are enforceable at all school—and non-school activities and events. The first meeting/practice in the current school year defines the beginning of the enforcement period for each activity. The last meeting/practice formal activity or competition defines the end of the enforcement period for each activity. A competition is generally defined as any formally scheduled game,—match or meet between other teams or schools. Activities and events include all formal performances or exhibitions by an extra-curricular or co-curricular group.

3. Student voluntarily seeking help

Any such student, without prior suspension or dismissal, who voluntarily initiates seeking help through school personnel for problems of use of alcohol or controlled substances will not be subject to 4.1 or 4.2 but will proceed to work with administrator to enroll in a drug/alcohol education program: or attending regular meeting with a counselor, assistance person or other designated individual; or performing a written behavior contract with progress reports or other such conditions as may be imposed. No student may benefit from this section more than once. To benefit from this section, the initial contact by the student must have clearly occurred before the students' drug or alcohol problem becomes the subject of criminal investigation, or suspension or expulsion from school.

- 4. <u>Consequences of student use of alcohol or controlled substance:</u> <u>First Offense</u> <u>During Student Career</u>
 - 4.1 Any such student who is reasonably suspected of using alcohol, tobacco or any other controlled substance shall be notified of such suspicion and granted a hearing before the appropriate administrator. Parents/guardian or counsel may attend hearing.
 - 4.2 If it is found, after hearing by the administrator, that probable cause exists to believe that the student has used alcohol or any controlled substance
 - 4.2.1.Suspension from the privileged activity in which student is participating until the end of the current extra-curricular activity.
 - 4.2.1 Receive no award letter or other recognition for such activity.
 - 4.2.2 Appeal from the ruling shall be to the school principal.
 - 4.2.3 <u>Discretionary Re-admission:</u> If probable cause does not exist and after a drug assessment, if alcohol or other drugs are involved, reinstatement may be achieved, at the discretion of the administrator, by requiring the student to enroll in a drug/alcohol education program; or attending regular meeting with a counselor, assistance person or other designated individual; or performing a written behavior/academic contact with progress reports, or such other condition as may be imposed.
- 5 <u>Second Offense</u>; Any student who uses alcohol or controlled substance a second time and probable cause exists shall:
 - 5.2 Be dismissed from the team or performance in competition or office for a calendar year.
 - 5.3 Receive no award letter or other recognition for such activity

6 Third offense:

Any student who uses alcohol or controlled substance, and probable cause exists a third time shall:

- 6.2 Not be allowed to participate in any extra-curricular activity for the duration of their high school career.
- 7 Consequences of student use of Tobacco in any form: First Offense
 - 7.2 If it is found, after a hearing by an administrator, that probable cause exists to believe that the student has used tobacco the administrator shall impose the following sanction:
 - 7.1.1 Suspension from privileged activity in which the student is participating for a period of no less than one game or seven days. Game suspension will be the next immediate contest.
 - 7.2 Second <u>or Future Offense</u>: Any student who uses again and probable cause exists at any time shall:

- 7.2.1 Be suspended from the sport or activity for the duration of the sport or activity
- 7.2.2 Receive no award or letter or other recognition for such activity
- 7.2.3 <u>Discretionary Re-admission:</u> If probable cause does not exist reinstatement may be achieved, at the discretion of the adjudicating administer, by the student enrolling in, and successfully completing a tobacco cessation program, or attending regular, meetings with a counselor, or such other conditions may be imposed.

8 Stealing:

Immediate suspension pending appropriate investigation and disciplinary action.

9 <u>Harassment/Bullying/Cyber Bullying/Hazing</u>:

Any offense, immediate suspension pending appropriate investigation and disciplinary action. See pages 15 and 16 in minimum standards for student conduct and discipline for definitions and clarifications.

10 Other Violations of Student Conduct Policies or Oregon Law:

- 10.2 Any athlete or student activities person, who brings discredit upon the individual, the team, or the school, by violating any school conduct policy, may be suspended or dismissed from activity pending outcome of investigation.
- 10.3 Any athlete or student activities person who is convicted of a crime shall be dismissed from participating in any extra/co-curricular activity for a calendar year.
