
KEENEYVILLE SCHOOL DISTRICT 20

Remote Learning Plan



Updated: April 5, 20



Overview

The purpose of this document is to provide information to the Keeneyville 20 community for implementing "remote learning" or "remote instruction" during the statewide school closure. The goal is to develop a remote learning plan that is inclusive of all students regardless of age, location, background and available resources.

Goals

- To support all students, the whole child social/emotionally, nutritionally and educationally.
- To reach every child within Keeneyville District 20.
- Provide opportunities for students to continue learning that focuses on <u>Illinois Learning</u>
 Standards.
- To provide routines and structures for both students and staff to encourage a predictable school day.
- To provide access to quality educational material both through digital and non-digital access to content.

Instructional Calendar

All of the days during the initial mandated statewide closure March 17 through March 30, 2020 will count as Act of God Days for all Districts. Keeneyville's spring break, March 30 to April 4. Beginning on April 6, we will utilize two of the five Remote Learning Planning Days with the goal to begin "Remote Learning" (also referred to as "Remote Instruction") on April 8 with all students.

School Day

Teachers will post assignments by 8:30 am each day. Teachers will be available to students and parents via email & Google Classroom/Seesaw from 8:30 am to 11:30 am and from 1:00 pm to 1:30 pm each school day. During these times, students and/or parents can ask questions regarding assignments. Teachers will determine the best way to meet the needs of every student whether that is digitally or non-digitally.

Attendance

Until additional guidance is provided by ISBE, all Remote Learning Days count as actual student attendance days. All students will be considered present for attendance purposes. Teachers should determine the best way to communicate with students and encourage continued instruction during these Remote Learning days.

If a student is sick, please call your child in to the office as you normally would do if school was in session. Teachers will work with parents and students to make sure they can make up any work.



Student Well-Being

Remote Learning should support social-emotional well-being as well as academic and linguistic development of the student. During the course of daily interaction with students, teachers will use their best efforts to determine if students have all the tools they need to be successful. Is their Chromebook working? Do they need non-digital resources? Do they have level reading opportunities? Do they have food? Parental support? Etc.

Assessment

Grading should be done on the principle of "no educational harm to any child" or a Pass or Incomplete. Any student who receives an incomplete has the opportunity to make up content. Grades may only increase a students' academic standing.

Below are recommended guidelines for engagement by students in remote learning activities:

6-8	Class: 15/minutes/day	Class: 30 minutes/day	1 subject area or class

Students will participate in one special per day and two daily subject areas. This will be a new routine for your student, be patient and allow students adequate time to learn the material. Ask for help when you need it. And communicate with teachers regularly.

The school district will continue to support students with diverse learning needs. The special education along with the general education teachers will collaborate to meet the needs of students with disabilities. In addition, related service members will support students on their caseload. A school based member of your child's IEP team will collaborate with you and checkin with your child to ensure that remote learning content is understood. Lastly, the school district will utilize paraprofessionals when possible to assist teachers with a variety of responsibilities.

The school district will continue to support English Language Learners during remote learning. The EL teachers will collaborate with the general education teachers to meet the needs of EL learners. In addition, if needed, there will be one day a week of interpretation services available



for teachers to communicate with parents.

Transition Plan

The District is in the process of developing a transition plan. This plan will include allowing students the following:

- Time to acclimate to the school setting and routines including social emotional time to discuss how they are feeling with the changes over the past weeks
- Analysis of students' remote learning work and areas that may need to be supported
- Development of plans for classes to resume and to support students in August of 2020

Conclusion

The well-being and safety of our students and staff continues to be of utmost importance to the District.
