CRITERIA FOR RECEIVING CREDIT THROUGH ONLINE LEARNING

- Students may not enroll in online courses without an application that has been signed by the student’s parent/guardian, counselor, and principal. The form should be submitted to the Director of Career Technical Education and Acceleration for approval.
- Cheating, plagiarism, or collaboration is not allowed when completing online course work. Students who violate the academic honesty or network usage policies will be dismissed from the online learning course.
- Online learning courses completed during the academic year are subject to a \$50.00 fee. Courses completed during the summer school session will be subject to summer school fees.
- The student is responsible for his/her own technology and for keeping up with assignments.
- The grade earned in the online course is the ACTUAL Grade in Edgenuity and is based on mastery of all required objectives. **The grade earned in the online course will be listed on the student’s high school transcript and count toward the student’s GPA, even if not passed.**
- All online learning courses will have a deadline date and any work not complete by this date will become a zero.

CREDIT RECOVERY ONLY – PARENT Must Initial

- The student must complete 100 percent of the required coursework within Edgenuity with a passing grade. **Credit recovery students will receive a grade equal to the lowest passing score (60) for the district.** If a student does not complete the online Edgenuity coursework prior to the assigned end date he/she will receive a zero for all uncompleted work.
