ADDITIONAL CONDITIONS OF CERTIFICATE ON BACK

CONDITIONS OF CERTIFICATE

- 1) Only the materials and quantities specified on the front of this certificate may be burned.
- 2) Only brush not greater than three (3) inches in diameter shall be burned.
- 3) No objectionable odors or excessive smoke may be created. All reasonable measures to assure complete combustion are to be taken.
- 4) All reasonable safety precautions are to be taken, including the clearing of grass and trees in the burning area, wetting down of the surrounding area, having an extinguisher or garden hose available when practical.
- 5) When the applicant is not the property owner, the applicant shall be the person who legally resides on the property and shall be responsible for notifying the property owner of the proposed burning prior to actual date of burning.
- 6) Verbal approval must also be obtained from the Fire Department official on duty on the day of and prior to the burning at this **telephone number: (860) 668-3888**
- 7) A responsible person must be on site during the burning and shall have a means of contacting the fire department in the event an emergency occurs.
- 8) Burning must be conducted between the hours of 10 a.m. and 5 p.m.
- 9) Fire must be completely extinguished by 5 p.m.
- 10) **Burning must not take place** (a) when national or state ambient air quality standards may be exceeded; (b) where a hazardous health condition might be created; (c) when forest fire danger in the area is identified by the commissioner of D.E.P as high or extreme and where woodland is within one hundred feet of the proposed burn; (d) where there is an advisory from the commissioner of D.E.P. of any air pollution episode; (e) where prohibited by an ordinance
- 11) Burning must cease if so directed by an official of the local Fire Marshal's Office, Fire Department, Police Department or State Department of Environmental Protection
- 12) This certificate must be immediately available at the burning site at all times during burning.
- 13) **Special Conditions applicable if checked:**
 - A fire-fighting truck must be stationed at the burn site.
