- 3. Can the request for the submission of 3 hard copies be adjusted in the RFP to have a digital copy (USB)?
 - a. Only two (2) electronic copies on USB drives are now required.
 - i. All packaging and identification required by the RFP must be followed
 - ii. The package must contain a hard copy of the bid from (original)
 - iii. The package must contain the original hard copy of the bid bond
