How does E-REC work?

Complete the Tax Return Online

- Go to portal.ct.gov/DRS. Under "Most Popular", click on Real Estate Conveyance Tax Electronic Filing.
- For first time users, go to the *E-REC* User Guide for step by step instructions for Submitters.
- Go to *E-REC* Login to file the tax return.
- Printer friendly validation page appears in the same format as a paper Form OP-236.

Complete the Payment Section and Submit the Tax Return to the Town Clerk

- Enter the account number and routing number for checking or savings account , if payment is required.
- To submit a payment from a trust or escrow account (such as IOLTA), provide debit code T200921220 to the bank.
- Submit the tax return. Make note of your tracking number; you will need to provide this to the Town Clerk.

Submit the Deed or Instrument for Recording to the Town Clerk

- **Paper** deeds or instruments should be provided to the Town Clerk with the *E-REC* tracking number.
- **Electronic** deeds or instruments should be sent via the electronic deed recording system with the *E-REC* tracking number.

Town Clerk Submits Tax Return to DRS

- The Town Clerk will verify, record, complete their portion, and submit to DRS.
- DRS will send a confirmation email to the submitter.

¹ DRS can only withdraw the amount authorized by the Submitter. Payment is not initiated until the return is accepted by the town clerk and the deed/ instrument is recorded. If DRS is not able to withdraw the amount due, the grantor will receive a bill from DRS.
