• Student Enrollment

Superintendent Dr. Canales presented enrollment information as of March 13, 2020, the last day when students physically attended school and attendance was taken.

- ➤ Enrollment for the 26th week of school is 17,175 for a difference of 155 less students than last year at the same time.
- The ADA comparison for the 26th week is 15,780 in 2020 vs 15891 in 2019, for a difference of 112 less. ADA percentage for 2020 is 96.20% vs. 96.81% for 2019.

Mr. Kennedy wanted to know if staff knew the reasons why students were withdrawing from school.


Dr. Canales mentioned that students were possibly moving to be with other family members for assistance during the school closure. Dr. Sergio Garcia and his team will follow up and forward information to the Board via the weekly update.

Dr. Rivera asked staff to make contact with the students to ensure that they are not leaving WISD to go to another school district. Dr. Canales informed the Board that staff will also be following up on return letters from about 500 families to ensure that students remain at WISD.

• Insurance

Mr. Mike De La Rosa, Risk Management/Employee Benefits Director, presented the following report.

- >The chart below reflects the total cost for claims, prescriptions, and fixed costs.
- >The total amount spent as of September 1, 2019 through March 31, 2020 is \$10,187,822.38 vs. \$10,980,153.90 in 2018-2019.
- •The decrease is \$792,331.52.



- >The chart below shows a comparison of the number of claims paid for year 2019-2020 (53) vs 2018-2019 (78).
- >The district has incurred \$215,659.26 for year 2019-2020 vs. \$209,754.16 for year 2018-2019.
- •The district is doing well in the workers' compensation program.
- >Actual claims have decreased, but the district has incurred \$15,000 more so far this year, due to the severity of the claims.



Questions from board members:

>Mr. Kennedy wanted to know how teachers were keeping track of students doing their homework, and what would happen if students did not do their work.

As per Mrs. Peterson, students are completing assignments online and engaging with teachers on a one to one basis. Teachers continue to reach out to students by phone.

>Dr. Rivera wanted to know the percentage of students who have not been reached through distance learning.

Mr. Abel Aguilar, Assistant Superintendent for Elementary Education, provided the following information.

- •The chart below reflects the latest counts of the number of students by campus, who are working online and those working through the use of instructional packets. Also listed are the number of students who have not been reached and the follow-up methods being used to contact the students.
 - >Staff has not been able to contact 828 students, approximately 5% of students.
 - >Principals and staff are working hard to locate the parents of these students.
 - The numbers have gone down as a result of these efforts.

- •Staff continues to focus on providing equity and access to all students for continuity of instruction through distance learning.
- •Counselor support and district level support is available for students.
- •Administrators are signing in to google classrooms as co-teachers to monitor the substance of lessons and work load, which will provide accountability for students and teachers.
- >Dr. Rivera asked if computers were being issued to students who did not have a device.
- •One device has been issued per family per campus. There have been cases where parents have asked for an additional device. Principals are working with families to issue out an additional device if available.
- •Dr. Canales shared that 6,000 devices were issued to students district-wide.
- >Mr. Nieto wanted to know if secondary students who are taking online classes aware that EOC testing had been waived. Students need to make sure they pass their class so they don't have to retake the test next year.
- •According to Mrs. Peterson, the teachers who teach English I & II, Algebra I, U.S. history, and biology have informed their students.

- >Mr. Nieto also asked if seniors who qualified for IGC's were informed.
 - •Mrs. Peterson pointed out that counselors had reached out to seniors by phone to let them know what was going on since the first week of the closure. They are also working to recover anyone who left the district who is supposed to graduate in 2020, to let them know of the opportunity if they get back in and finish their credit.
- >Mr. Erasmo Lopez wanted to know who students should reach out to if they are in need of more devices.
- •Parents/students should reach out to their campus principal.
- >Dr. Rivera wanted to know how staff decided on posting dates for graduations if no one is still certain if summer graduations will occur.
- •Mrs. Peterson replied that staff is not certain that graduations will occur; however, they wanted to let the seniors know that staff is thinking of them and looking for options if there is a possibility to have them. Staff is looking into what other parts of the state is doing. As mentioned on the flyer, graduations are pending and will depend on what is happening with the on-going crisis.
- •Dr. Rodriguez commented that it was a good idea to put out dates because it gives students and parents hope that there might be something to look forward to. He stated, "If it doesn't happen, that's beyond our control, so thank you for lifting a lot of spirits up during these times." He has a son who is a senior and appreciated their efforts.
- •Mr. Armando Cuellar commended everyone for their efforts in what they are doing for the students and employees under these circumstances.
- >Mr. Patrick Kennedy wanted to know how distance learning would affect teacher evaluations.
- •During the consent agenda, the administration will be asking the Board to approve a waiver that will waive the 45-minute observations for teachers for whom staff has not yet completed that requirement (less than 13%).
- •The summatives will be completed. Staff has walk-thru information and data on almost all teachers.

Dr. Rivera pointed that he was not against having graduations. However, due to the uncertainty of what is going on, he would have liked to have a better understanding, prior to posting these dates, if graduations could occur. If it is possible he would like to have graduations sometime in June, July, or August.

Dr. Canales applauded the teachers, principals, and central office administration for their hard work in making sure that learning continues in a way that promotes the great vision and mission and goals of this district.

XII. Consent Agenda

Items D and F were pulled from the agenda by the administration. The programs have been cancelled. Items L and Q were pulled out for discussion by Dr. Richard Rivera.

Patrick Kennedy made the motion to approve the consent agenda with the exception of Items D, F, G, and L. Andrew Gonzalez seconded the motion.

A. Approval of the Minutes of the Regular Board Meeting of March 9, 2020 and the Emergency Meeting of March 20, 2020

The Board approved the minutes as presented.

B. Approval of Purchase of English III AP and English IV AP Textbooks for Year 2020-2021

The Board approved the sole purchase of English III AP and English IV AP textbooks from Bedford, Freeman and Worth High School Publishers for use in school year 2020-2021. The cost of this purchase is \$36,199.54.

English AP teachers reviewed sample textbooks over a two-week period and heard a presentation from the vendor on March 5, 2020. This vendor was the preferred publisher.

C. Approval of Purchase of Scholastic Classroom Libraries for PK-12 Bilingual/ESL English Language Arts Classrooms

The Board approved the purchase of Scholastic classroom library sets for all Pre-K-12 Bilingual/ESL English Language Arts Classrooms. The cost of this purchase is \$100,000.00.

The implementation of Scholastic classroom libraries that include high-interest reading and a variety of genres and reading levels, fosters a love for reading for English learners. In our efforts to ensure that all students "Read and Lead" at Weslaco ISD, these classroom libraries will provide students a large assortment of leveled readers where students will read at their comfort level but also have the opportunity to read at a level that challenges them.

D. Approval of Memorandum of Understanding Between Weslaco Independent School District and South Texas College for the Continuation of the Texas Pre-Freshmen Engineering Program (TEX-PREP) for the 2020-2021 School Year

This item was pulled from the agenda by administration.

E. Approval of Interlocal Cooperation Contract Between Weslaco Independent School District and the University of Texas Rio Grande Valley for the Continuation of the Texas Pre-Freshmen Engineering Program (TEX-PREP) for the 2020-2021 School Year

The Board approved the Interlocal Cooperation Contract with the University of Texas Rio Grande Valley for the continuation of the Texas Pre-Freshmen Engineering Program (TexPrep) for the 2020-2021 school year.

This program, which originated at the University of Texas-San Antonio in 1979, began as an extension at UTPA in 1986. UTRGV is one of twenty-five institutions in Texas who offers this program. The TexPrep program will provide educational enrichment opportunities for high ability 8th grade through 11th grade students interested in pursuing Mathematics, Science, or Engineering degrees, which is the program's primary goal.

UTRGV will invoice WISD \$425.00 per student who is certified as being in attendance on the third week in June. WISD will provide transportation for students to and from the university. A total of twenty-five students have applied and qualified for the program.

F. Approval of Interlocal Cooperation Contract Between Weslaco Independent School District and the University of Texas Rio Grande Valley for the Continuation of the 2020 Railway Safety Summer Engineering/Robotics Camp

This item was pulled from the agenda by administration.

G. Approval of Quarterly Investment Activity Report for the Quarter Ended February 29, 2020

This item was pulled out for discussion by Dr. Richard Rivera.

H. Approval of Purchase of Cardonex Data Integration System

The Board approved the sole source purchase of the Cardonex Data Integration System to facilitate and support the process of creating the master schedule at each of the secondary campuses. Principals and administrators involved with maser schedule creation, high school counselors, and district technology staff were all involved in making this decision. The cost of this purchase is \$78,959.00.

The creation of the master schedule is an intensive process that takes many hours each spring and summer. This product will help facilitate the process and shorten the amount of time it takes to create a schedule. Cardonex uses algorithms that take into consideration student request and staffing ratios to create a master schedule that supports students' academic needs while maximizing district resources.

I. Approval of Career and Technical Education (CTE) Innovative Courses to Offer State Elective Credit to High School Students: Microbiology and Safety for Cosmetology Careers (N1302540)

The Board approved the CTE innovative course: Microbiology and Safety for Cosmetology Careers (N1302540) to offer state elective credit to high school students. This course includes the study of microbes, pathogens, and the body's ability to defend itself against infection. It will prepare the cosmetology students with the knowledge and skills to be safe and protect themselves, coworkers, and members of the public in the workplace. This course will provide students the opportunity to demonstrate their understanding by solving an in-depth analytical problem concerning occupational health and safety in Cosmetology.

J. Approval to Ratify the Waiver from the Educator Appraisal Requirement Due to COVID-19

WISD uses the Texas Teacher Evaluation and Support System (T-TESS) to annually evaluate all Weslaco ISD teachers. One part of the annual appraisal is a 45 minute observation of the teacher in his/her classroom. Due to the unexpected and prolonged school closure, this requirement will not be able to be completed for all WISD teachers. Therefore, the district submitted a waiver to the Texas Education Agency from the Educator Appraisal Requirements due COVID-19 and the waiver was approved.

There are 1,106 teachers in the district. Administrators were able to complete 45 minute observations for 958 teachers, 87%. The number of teachers who did not have the 45 minute observation this year is 148 (13%). Nonetheless, campus staff completed and documented multiple walk-throughs for these teachers. These will serve as a source of information and will be used to complete the T-TESS summative evaluation for the 2019-2020 school year. For teachers who do not have any documented walk-throughs, the administrator and teacher will complete the summative observation together based on last year's evaluation.

The Board approved the waiver submitted to TEA.

K. Approval of the Revised Weslaco I.S.D. Guidelines for Grading for the Fifth and Sixth Six Weeks of the 2019-2020 School Year

The Board approved the revised Weslaco ISD guidelines for grading for the fifth and sixth six weeks of the 2019-2020 school year.

The WISD guidelines for grading are published each August in the WISD Student Handbook. It was necessary to review and revise the guidelines due to the extended period of school closure mandated by Governor Abbott.

Central Office administrators and principals drafted revised guidelines which were shared with teacher leaders for their input and feedback. Revisions were made based on the input received. Final guidelines for grading for the fifth and sixth six weeks of the 2019-2020 school year were developed and will be posted on the Weslaco I.S.D. website.

L. Approval of Athletic Summer Programs

This item was pulled out for discussion.

M. Approval of Proposal Awards for Lumber Supplies & Equipment (Proposal #20-04-19)

A request for proposals were sent to twenty-one vendors and only six proposals were received. The Board awarded the proposal for lumber supplies and equipment to the following vendors:

- •American Industrial Supplies Pharr, Texas
- •HL Flake Security Hardware Houston, Texas
- •McCoy's Building Supply Weslaco, Texas

G. Approval of Quarterly Investment Activity Report for the Quarter Ended February 29, 2020

This item was pulled out by Dr. Richard Rivera. Dr. Rivera wanted to know how the district planned to use the total investment earnings in the amount of \$739,800.45.

- The investment earnings amount for this quarter is \$381,831.22
- The total investment earnings amount to date (Sept. 1, 2019 Feb. 29, 2020) is \$739,800.45

The investment activity report covers the following accounts: Local Maintenance, Payroll, Debt Service, Construction, 2017 Maintenance Tax Note, 2018 Maintenance Tax Note, Self-Insurance Workers' Compensation, Unemployment Fund, Health Insurance and Debt Service-Taxes.

Mr. Andres Sanchez explained that the earnings are part of the budget which provides the revenues that will be used to meet the expenditures. Any amount that is not used will go towards fund balance.

L. Approval of Athletic Summer Programs

This item was pulled out by Dr. Richard Rivera.

Dr. Rivera wanted to know if staff had a plan in place in case the district was not able to provide these programs in June due to the school closure. He would like to extend the program to July or August to allow the students to participate in the athletic summer programs.

Mr. Andres Cantu, Assistant Athletic Director, agreed.

Mr. Andres Sanchez confirmed that monies for the athletic summer programs has been allocated in the budget so the programs can be extended for a later date.

Patrick Kennedy amended his motion to include approval of Items G & L. Andrew Gonzalez seconded, and the motion passed unanimously.

XIII. Discussion Items:

A. Interim Financial Report for the Seven Months Ended March 31, 2020

The Board acknowledged the Interim Financial Report for the seven months ended March 31, 2020, as prepared by the Business Office.

- For total revenues budgeted of \$183,844,750, the district has received \$125,087,554 which represents 68.04% of the budget.
- Of \$190,485,474% in budgeted expenditures, the district has expended or encumbered \$101,638,983 which represents 53.36%.

Mr. Sanchez explained that purchases for functions 34 (Transportation), 35 (Food Services); and 36 (Co-Curricular) are usually made a month in advance and that is why the accounts are already at 66%, 67%, and 63%. The accounts will start leveling off towards the end of the school year since there will be no further spending in June or July.

Dr. Rivera asked that the departments be allowed to continue processing purchase orders for items they need at this time or for the summer. Mr. Sanchez replied that Business Office will be working with staff on processing their purchase orders.

B. Acknowledgement of Hidalgo County Tax Office Collection Report for February 2020: Current Taxes and Delinquent Taxes

The Board acknowledged the Collection Report for February 2020 as presented. Section 31.10 Property Tax Code requires the Tax Assessor/Collector to submit to the governing body of the taxing unit a written report made under oath accounting for all taxes collected for the unit during the preceding month.

- The collection of **current taxes** for fiscal year 2019-2020 through February 29 is 0.66% higher than the current taxes for fiscal year 2018-2019.
- The collection of **delinquent taxes** for fiscal year 2019-2020 through February 29 is 2.21% lower than the delinquent taxes for fiscal year 2018-2019.
- The column for tax modifications represents the cumulative tax adjustments reported by the Hidalgo County Tax Office for the 2019-2020 fiscal year in their February 2020 report.

>Mr. Kennedy inquired on the actual collections presented:

According to Mr. Sanchez, the district budgeted 92% for the year and so far have collected 87.78% for half the year. The biggest portion is the current levy that is collected through February. In March, the percent starts going down; therefore, 87.78% is good compared to last year's collections.

The district budgeted 20% for the delinquent taxes. Collections are usually 20% to 23% by the end of the year. There are still six months to collect; however, collections might be lower than 20% because there are tax payers who might not have a job or money to pay their taxes due to COVID-19.

XIV. Discussion and Possible Action Items:

A. Discussion and Possible Action to Declare a Catastrophe and Delegate to the Superintendent the Authority to Take All Necessary Actions Moving Forward Pertaining to a Temporary Suspension of the Texas Public Information Act Pursuant to Section 552.233 of the Texas Government Code

Due to the pandemic, the Superintendent recommended that the Board approve a resolution to declare a catastrophe and delegate to the Superintendent the authority to take all necessary actions moving forward pertaining to a temporary suspension of the Texas Public Information Act pursuant to Section 552,233 of the Texas Government Code.

Legal counsel has conferred with the state Attorney General's office on this issue and informed that the AG's office is being understanding with District's during the emergency closure as it pertains to responses to public information requests. Nonetheless, legal counsel recommended invoking this section of the Government Code as conservative advice.

Dr. Richard Rivera made a motion to approve the resolution as presented. Andrew Gonzalez seconded the motion and it passed unanimously.

B. Discussion and Possible Action to Approve a Resolution Tolling Deadlines Found in Local Policies DGBA, FNG and GF During the Emergency Closure

Due to the pandemic and closure, the Superintendent recommended that the Board approve a resolution rendering all deadlines found in local policies DGBA (Local), FG (Local) and GF (Local), tolled beginning on March 23, 2020, and remain tolled through the duration of the emergency closure. The recommendation is based on the belief that:

- A need exists to address the timelines in current local policies when it comes to the constitutional rights of students, staff and community (citizens) to apply to those invested with the powers of government for redress of grievances or other purposes and concludes that a public purpose is served by tolling deadlines found in District policies DGBA (Local), FNG (Local) and GF (Local) during the emergency closure beginning on March 23, 2020; and
- A substantial public purpose exists in protecting the health and safety of its students, staff, and
 community and therefore in ensuring that the school district and community are prepared to the
 fullest extent possible to protect the health and safety of students, staff, and community in light
 of COVID-19.

Dr. Richard Rivera made the motion to approve the resolution as presented. Andrew Gonzalez seconded the motion and it passed unanimously.

C. Discussion and Possible Action for the Board to Consider Approval of the 2020-2021 Academic Calendar

Mrs. Sue Peterson, Assistant Superintendent for Secondary Education & Leadership, provided the following information on the creation and selection of the academic calendar.

- Three options of the Academic Calendar were created by a subcommittee of the District Advisory Committee.
- The District Advisory Committee approved the three options presented.
- All three proposed calendars were posted on the district website on March 31 for parent and staff voting. Voting remained open through April 13.
- Messages were sent to the WISD family on March 31, April 8 and before the close of voting on April 13.

The administration recommended Option 1.

Due to rescheduling dates of many events, Mr. Erasmo Lopez asked if it was necessary to take action on the calendar at this time.

Dr. Canales informed the Board that administration would have to initiate an amendment to the approved calendar and seek board ratification at a later date in the event the Texas Education Agency mandates or provides direction on adjustments to the 2020-2021 school calendar due to the current COVID-19 pandemic. The administration will proceed in working towards having a Plan A and B; however, at this time the administration has done a lot of planning for Plan A which includes the return date in August and based upon this, a Plan B will be developed in the event the district is not ready to start on the first day of school as scheduled on the calendar.

Patrick Kennedy made the motion to approve Option 1 as recommended by administration. Dr. Jaime Rodriguez seconded the motion and it passed unanimously.

D. Discussion and Possible Action for the Board to Consider Approval of Proposal Award for Third Party Administrative Services for the District's Self-Funded Employee Benefit Program (RFP #20-04-17)

The district solicited proposals for Third Party Administrative Services (TPA). Three (3) proposals were received. Valley Risk Consulting (VCR) conducted a thorough review of the three proposals and recommended award to BCBS of Texas. The proposals from BCBS includes a PBM rebated credit of approximately \$43.70 per employee per month to offset the administration fees. After analyzing all the assumptions and exceptions within the submitted offers, BCBS closely met the RFP requirements. Staff did not find any proposal that justified a

change of administrators at this time and because of the current pandemic, the committee felt that continuity of medical benefits was essential during this time of uncertainty.

Mr. Lopez concurred with the recommendation to keep continuity with this insurance since there were no changes at this time.

Dr. Richard Rivera made the motion to approve the proposal from Blue Cross Blue Shield to provide Third Party Administrative Services for the District's Self-Funded Employee Benefit Program as recommended by Valley Risk Consulting. Erasmo Lopez seconded the motion and it passed unanimously.

E. Discussion and Possible Action for the Board to Consider Approval of Proposal Award for Pharmacy Benefit Management Services for the District's Self-Funded Employee Benefit Program (RFP #20-04-17)

The District solicited proposals for Pharmacy Benefits Manager (PBM) under RFP# 20-04-17. Local and National media outlets and public purchasing websites were utilized to advertise to obtain competitive proposals. The district received six (6) proposals and all proposals were evaluated for transparency, drug pricing and favorable contractual terms. The participating vendors were Prime Therapeutics Rx (incumbent), Araya Rx, AmWins Rx, Heritage Health Solutions, Humana, and Medalist Rx.

VRC reviewed the proposals and determined that four (4) vendors met the District's expectations and were invited to participate in a best and final offer request. Prime Therapeutics offered the most competitive proposal including a rebate credit of \$43.70 per employee per month (PEPM). This credit is greater than the total administration cost for the TPA services. The Rx ingredient cost was considered as a major pricing factor. The ingredient cost is a measurement of the overall claim cost to the district's plan.

Mr. Mike De La Rosa, Director of Employee Benefits & Risk Management, informed the Board that the district received \$500,000 in rebates last year. This year, in lieu of receiving cash rebates from the pharmacy benefit managers, Prime Therapeutics offered a per employee per month credit of \$43.70, which totals to approximately \$1.2 million and is a better deal.

Erasmo Lopez made the motion to approve the proposal from Prime Therapeutics/BCBS to provide PBM services for the District's self-funded employee benefit program. Dr. Richard Rivera seconded the motion and it passed unanimously.

F. Discussion and Possible Action for the Board to Consider Approval of Proposal Award for Dental Insurance (RFP #20-04-18)

Patrick Kennedy changed the order of the day to discuss Item F prior to Item E.

As part of a comprehensive package of benefits, the district provides basic dental insurance at no cost to employees. Eligible employees may add their dependents to the dental plan at a reduced rate. Employees also have the option to "buy up" to a higher dental plan with expanded benefits.

The district received eight (8) proposals with multiple options. The participating vendors are Lincoln Financial (incumbent), Ameritas, MetLife, Delta Dental, Blue Cross Blue Shield, UNUM, TML, and United Health Care. The proposals were tabulated and evaluated under a predetermined matrix grid to evaluate the vendors on a line item service basis. Best and final offers were requested from the top-three proposals. As per the matrix results from the BAFO,

Ameritas offered the best value to the District. Amerita's proposal offered a two-tier benefit structure which merged the current base and mid plan to offer a comprehensive benefit package to employees who utilize the base plan at no cost. WISD will contribute \$10.48 per employee per month (PEPM) for the next plan year.

Dr. Jaime Rodriguez made the motion to approve the proposal from Ameritas to provide dental insurance benefits for Weslaco ISD's employee benefit plan. Erasmo Lopez seconded the motion and it passed unanimously.

G. Discussion and Possible Action for the Board to Consider Selection of Servicing Agent for Dental Insurance (RFP #20-04-18)

The District conducted an RFP process and received proposals from the following agents:

- Salazar Insurance Group
- Jeff Everett & Associates
- Yvonne Ortegon Insurance
- Tamez Financial Services
- First Public

The selection of servicing agent(s) is at the discretion of the Board.

Questions from the Board:

Dr. Rivera wanted to know the names of the agents currently servicing the district. >Services are split between Tamez & Salazar Insurance Group

Dr. Rivera made the motion to go with Tamez Financial Services and have him select agents from the list. Armando Cuellar seconded the motion.

Dr. Rodriguez inquired on the process for enrollment.

>According to Mr. De La Rosa, the district will use a system called a soft enrollment. Since the district pays the premium for the base plan the district would just transfer the file from the current company over to the new company, and any employee who needs to make changes will have to meet with the agents selected to make the desired changes to their plan.

Andrew Gonzalez suggested that the Board split the services between the agents from Weslaco and have them select who they want.

A vote was called for on the motion made by Dr. Rivera and seconded by Mr. Cuellar to select Tamez Financial Services and have him select agents from the list provided. Voting in favor of the motion were Dr. Rivera, Armando Cuellar, Erasmo Lopez, Dr. Jaime Rodriguez, and Patrick Kennedy. Andrew Gonzalez voted against the motion. Motion carried with a 5 to 1 vote.

H. Discussion and Possible Action to Appoint Servicing Agent(s), at No Additional Cost to the Weslaco ISD or Weslaco ISD Staff for Third-Party Administrator Services (RFP #20-04-17)

This item was requested by Board President Isidoro Nieto for the purpose of clearing up the ambiguity about the selection of agents for TPA services as a result of a discussion held at the Board Workshop on April 16, 2020.

Andrew Gonzalez made the motion to appoint Jeff Everitt & Associates, Tamez Financial Services and Yvonne Ortegon Insurance as servicing agents for Third-Party Administrator Services at no additional cost to WISD or WISD staff. Dr. Jaime Rodriguez seconded the motion.

Questions from the Board:

Dr. Rivera wanted to know the names of the agents currently servicing the district. >Jeff Everitt & Associates and Tamez Financial

A vote was called for on the motion made by Andrew Gonzalez and seconded by Dr. Jaime Rodriguez to appoint Jeff Everitt & Associates, Tamez Financial Services and Yvonne Ortegon Insurance as servicing agents for Third-Party Administrator Services at no additional cost to WISD or WISD staff. Voting in favor of the motion were Andrew Gonzalez, Dr. Jaime Rodriguez, Patrick Kennedy, Erasmo Lopez, Dr. Richard Rivera, and Armando Cuellar. Motion carried.

Mr. Lopez wanted to know who would take the lead and whether the Board could delegate someone to be in charge. Mr. De La Rosa replied that the selected agents would have to work it out among themselves.

Dr. Rivera agreed with Mr. Lopez on having someone in charge of all three agents.

As per the advice of the school attorney, the board president announced that all three agents would meet in one month to make a decision. Since the Board had already voted, the Board could come back at that time to amend the motion to appoint one of the agents if necessary.

- I. Discussion and Possible Action for the Board to Consider Approval for the Fire Alarm and Security Alarm Systems Project at Weslaco High School and Fire Alarm System Project at Central Office Administrative Complex (CSP #18-02-17) as Follows:
 - 1. An Allowance Expenditure for Additional Work Needed,
 - 2. A Deductive Change Order for the Unspent Owner's Contingency and Project Credits, Including Delay Days to Complete the Project, and
 - 3. Final Completion of the Project

On February 12, 2018, the Board approved Superior Alarms for the construction of this project in the amount of \$568,330. The project scope consisted of the replacement of the fire and security alarm systems at the Weslaco High School and the replacement of the fire alarm system at the Central Office Administrative Complex.

According to Mr. Andres Sanchez, the project was completed except for the portion that covered the athletic facility that was being renovated at the time, but is now completed. The installation of the fire and security alarm systems on this project was dependent on the completion of the WHS Athletic Building Remodeling project which caused the 431 delay days requested by Superior Alarms. Thus, the delay days was not the company's fault. Staff is recommended approval of the expenditure allowance for additional work that was needed and a credit balance to the district for the amount of the allowance not used, which will end up being \$1,995.50. This amount includes work that has not been completed. The final project cost is \$568,330.00. A total of \$466,597.71 has been paid to the contractor and a total of \$92,876.03 remains to be paid to the contractor.

Mr. Americo Garza, Director of Energy Systems/Maintenance & Operations, confirmed that the delay was primarily due to the contractor on the other project who did not complete the remodeling of the old field house on time, which overlapped the installation project of the fire alarm systems.

Dr. Richard Rivera made the motion to approve the allowance expenditure for additional work needed, a deductive change order for the unspent owner's contingency balance and project credits, including delay days to complete the project, and the final completion of the project. Armando Cuellar seconded the motion and it passed unanimously.
