25 Kane Street — Application (IWW#1123) of Thomas R. Evans (R.O.), requesting approval of an Inland Wetlands and Watercourses Permit to conduct certain regulated activities, which may have an adverse impact on a wetland and watercourse area. The applicant is proposing a restoration and enhancement project in response to a Notice of Inland Wetlands & Watercourse Violation issued by the Designated Agent for work without permits within a regulated area.
